## 3 Subject content

---

Sections 1–4 are designed to be covered in the first year of the A-level and are also the AS subject content. So you can teach AS and A-level together.

Each section begins with an overview, which puts the topic into a broader biological context and encourages understanding of the place of each topic within the subject. The overview is intended to encourage an overarching approach to both the teaching and learning of topic areas. As such, it will not be directly assessed.

These specifications are presented in a two-column format. The left-hand column contains the specification content that all students must cover and that can be assessed in written papers. The right-hand column exemplifies the opportunities for skills to be developed throughout the course. As such, knowledge of individual experiments on the right-hand side is **not** assumed knowledge for the assessment.

The codes in the right-hand column refer to the skills in the relevant appendices. **MS** refers to the Mathematical Skills, **AT** refers to the Apparatus and Techniques and **PS** refers to the Practical Skills.

## 3.1 Biological molecules

All life on Earth shares a common chemistry. This provides indirect evidence for evolution.

Despite their great variety, the cells of all living organisms contain only a few groups of carbon-based compounds that interact in similar ways.

Carbohydrates are commonly used by cells as respiratory substrates. They also form structural components in plasma membranes and cell walls.

Lipids have many uses, including the bilayer of plasma membranes, certain hormones and as respiratory substrates.

Proteins form many cell structures. They are also important as enzymes, chemical messengers and components of the blood.


Nucleic acids carry the genetic code for the production of proteins. The genetic code is common to viruses and to all living organisms, providing evidence for evolution.

The most common component of cells is water; hence our search for life elsewhere in the universe involves a search for liquid water.

### 3.1.1 Monomers and polymers

Content	Opportunities for skills development
<p>The variety of life, both past and present, is extensive, but the biochemical basis of life is similar for all living things.</p> <p>Monomers are the smaller units from which larger molecules are made.</p> <p>Polymers are molecules made from a large number of monomers joined together.</p> <p>Monosaccharides, amino acids and nucleotides are examples of monomers.</p> <p>A condensation reaction joins two molecules together with the formation of a chemical bond and involves the elimination of a molecule of water.</p> <p>A hydrolysis reaction breaks a chemical bond between two molecules and involves the use of a water molecule.</p>	

### 3.1.2 Carbohydrates

<p>Monosaccharides are the monomers from which larger carbohydrates are made. Glucose, galactose and fructose are common monosaccharides.</p> <p>A condensation reaction between two monosaccharides forms a glycosidic bond.</p> <p>Disaccharides are formed by the condensation of two monosaccharides:</p> <ul style="list-style-type: none"> <li>• maltose is a disaccharide formed by condensation of two glucose molecules</li> <li>• sucrose is a disaccharide formed by condensation of a glucose molecule and a fructose molecule</li> <li>• lactose is a disaccharide formed by condensation of a glucose molecule and a galactose molecule.</li> </ul> <p>Glucose has two isomers, <math>\alpha</math>-glucose and <math>\beta</math>-glucose, with structures:</p> <div style="text-align: center;">  <p><math>\alpha</math>-glucose                      <math>\beta</math>-glucose</p> </div> <p>Polysaccharides are formed by the condensation of many glucose units.</p> <ul style="list-style-type: none"> <li>• Glycogen and starch are formed by the condensation of <math>\alpha</math>-glucose.</li> <li>• Cellulose is formed by the condensation of <math>\beta</math>-glucose.</li> </ul> <p>The basic structure and functions of glycogen, starch and cellulose. The relationship of structure to function of these substances in animal cells and plant cells.</p> <p>Biochemical tests using Benedict's solution for reducing sugars and non-reducing sugars and iodine/potassium iodide for starch.</p>	<p><b>AT f</b></p> <p>Students could use, and interpret the results of, qualitative tests for reducing sugars, non-reducing sugars and starch.</p> <p><b>AT g</b></p> <p>Students could use chromatography, with known standard solutions, to separate a mixture of monosaccharides and identify their components.</p> <p><b>AT c</b></p> <p>Students could produce a dilution series of glucose solution and use colorimetric techniques to produce a calibration curve with which to identify the concentration of glucose in an unknown solution.</p>

### 3.1.3 Lipids

Content	Opportunities for skills development
<p>Triglycerides and phospholipids are two groups of lipid.</p> <p>Triglycerides are formed by the condensation of one molecule of glycerol and three molecules of fatty acid.</p> <p>A condensation reaction between glycerol and a fatty acid (RCOOH) forms an ester bond.</p> <p>The R-group of a fatty acid may be saturated or unsaturated.</p> <p>In phospholipids, one of the fatty acids of a triglyceride is substituted by a phosphate-containing group.</p> <p>The different properties of triglycerides and phospholipids related to their different structures.</p> <p>The emulsion test for lipids.</p> <p><b>Students should be able to:</b></p> <ul style="list-style-type: none"> <li>• recognise, from diagrams, saturated and unsaturated fatty acids</li> <li>• explain the different properties of triglycerides and phospholipids.</li> </ul>	<p><b>AT f</b></p> <p>Students could use, and interpret the results of, the emulsion test for lipids.</p>

## 3.1.4 Proteins

### 3.1.4.1 General properties of proteins


Content	Opportunities for skills development
<p>Amino acids are the monomers from which proteins are made. The relationship between primary, secondary, tertiary and quaternary structure, and protein function.</p> <p>The biuret test for proteins.</p> <p><b>Students should be able to</b> relate the structure of proteins to properties of proteins named throughout the specification.</p>	<p><b>AT f</b></p> <p>Students could use, and interpret the results of, a biuret test for proteins.</p> <p><b>AT g</b></p> <p>Students could use chromatography with known standard solutions, to separate a mixture of amino acids and identify their components.</p>

### 3.1.4.2 Many proteins are enzymes

Content	Opportunities for skills development
<p>Each enzyme lowers the activation energy of the reaction it catalyses.</p> <p>The induced-fit model of enzyme action.</p> <p>The properties of an enzyme relate to the tertiary structure of its active site and its ability to combine with complementary substrate(s) to form an enzyme-substrate complex.</p> <ul style="list-style-type: none"> <li>• The specificity of enzymes</li> <li>• The effects of the following factors on the rate of enzyme-controlled reactions – enzyme concentration, substrate concentration, concentration of competitive and of non-competitive inhibitors, pH and temperature.</li> </ul> <p><b>Students should be able to:</b></p> <ul style="list-style-type: none"> <li>• appreciate how models of enzyme action have changed over time</li> <li>• appreciate that enzymes catalyse a wide range of intracellular and extracellular reactions that determine structures and functions from cellular to whole-organism level.</li> </ul>	<p><b>MS 0.5</b></p> <p>Students could be given the hydrogen ion concentration of a solution in order to calculate its pH, using the formula:</p> $pH = -\log_{10}[H^+]$

### 3.1.5 Nucleic acids are important information-carrying molecules

#### 3.1.5.1 Structure of DNA and RNA


Content	Opportunities for skills development
<p>Deoxyribonucleic acid (DNA) and ribonucleic acid (RNA) are important information-carrying molecules. In all living cells, DNA holds genetic information and RNA transfers genetic information from DNA to the ribosomes.</p> <p>Ribosomes are formed from RNA and proteins.</p> <p>Both DNA and RNA are polymers of nucleotides. Each nucleotide is formed from a pentose, a nitrogen-containing organic base and a phosphate group:</p>  <p>The diagram illustrates the structure of a nucleotide. It consists of three main components: a phosphate group, a pentose sugar, and a nitrogen-containing organic base. ### 3.1.5.2 DNA replication

Content	Opportunities for skills development
<p>The semi-conservative replication of DNA ensures genetic continuity between generations of cells.</p> <p>The process of semi-conservative replication of DNA in terms of:</p> <ul style="list-style-type: none"> <li>• unwinding of the double helix</li> <li>• breakage of hydrogen bonds between complementary bases in the polynucleotide strands</li> <li>• the role of DNA helicase in unwinding DNA and breaking its hydrogen bonds</li> <li>• attraction of new DNA nucleotides to exposed bases on template strands and base pairing</li> <li>• the role of DNA polymerase in the condensation reaction that joins adjacent nucleotides.</li> </ul> <p><b>Students should be able to</b> evaluate the work of scientists in validating the Watson–Crick model of DNA replication.</p>	

### 3.1.6 ATP

Content	Opportunities for skills development
<p>A single molecule of adenosine triphosphate (ATP) is a nucleotide derivative and is formed from a molecule of ribose, a molecule of adenine and three phosphate groups.</p>  <p>Hydrolysis of ATP to adenosine diphosphate (ADP) and an inorganic phosphate group (Pi) is catalysed by the enzyme ATP hydrolase.</p> <ul style="list-style-type: none"> <li>• The hydrolysis of ATP can be coupled to energy-requiring reactions within cells.</li> <li>• The inorganic phosphate released during the hydrolysis of ATP can be used to phosphorylate other compounds, often making them more reactive.</li> </ul> <p>ATP is resynthesised by the condensation of ADP and Pi. This reaction is catalysed by the enzyme ATP synthase during photosynthesis, or during respiration.</p>	

### 3.1.7 Water

Content	Opportunities for skills development
<p>Water is a major component of cells. It has several properties that are important in biology. In particular, water:</p> <ul style="list-style-type: none"> <li>• is a metabolite in many metabolic reactions, including condensation and hydrolysis reactions</li> <li>• is an important solvent in which metabolic reactions occur</li> <li>• has a relatively high heat capacity, buffering changes in temperature</li> <li>• has a relatively large latent heat of vaporisation, providing a cooling effect with little loss of water through evaporation</li> <li>• has strong cohesion between water molecules; this supports columns of water in the tube-like transport cells of plants and produces surface tension where water meets air.</li> </ul>	

### 3.1.8 Inorganic ions

Content	Opportunities for skills development
<p>Inorganic ions occur in solution in the cytoplasm and body fluids of organisms, some in high concentrations and others in very low concentrations.</p> <p>Each type of ion has a specific role, depending on its properties.</p> <p><b>Students should be able to</b> recognise the role of ions in the following topics: hydrogen ions and pH; iron ions as a component of haemoglobin; sodium ions in the co-transport of glucose and amino acids; and phosphate ions as components of DNA and of ATP.</p>	

## 3.2 Cells

All life on Earth exists as cells. These have basic features in common. Differences between cells are due to the addition of extra features. This provides indirect evidence for evolution.

All cells arise from other cells, by binary fission in prokaryotic cells and by mitosis and meiosis in eukaryotic cells.

All cells have a cell-surface membrane and, in addition, eukaryotic cells have internal membranes. The basic structure of these plasma membranes is the same and enables control of the passage of substances across exchange surfaces by passive or active transport.

Cell-surface membranes contain embedded proteins. Some of these are involved in cell signalling – communication between cells. Others act as antigens, allowing recognition of ‘self’ and ‘foreign’ cells by the immune system. Interactions between different types of cell are involved in disease, recovery from disease and prevention of symptoms occurring at a later date if exposed to the same antigen, or antigen-bearing pathogen.

### 3.2.1 Cell structure

The cell theory is a unifying concept in biology.

#### 3.2.1.1 Structure of eukaryotic cells

Content	Opportunities for skills development
<p>The structure of eukaryotic cells, restricted to the structure and function of:</p> <ul style="list-style-type: none"> <li>• cell-surface membrane</li> <li>• nucleus (containing chromosomes, consisting of protein-bound, linear DNA, and one or more nucleoli)</li> <li>• mitochondria</li> <li>• chloroplasts (in plants and algae)</li> <li>• Golgi apparatus and Golgi vesicles</li> <li>• lysosomes (a type of Golgi vesicle that releases lysozymes)</li> <li>• ribosomes</li> <li>• rough endoplasmic reticulum and smooth endoplasmic reticulum</li> <li>• cell wall (in plants, algae and fungi)</li> <li>• cell vacuole (in plants).</li> </ul> <p>In complex multicellular organisms, eukaryotic cells become specialised for specific functions. Specialised cells are organised into tissues, tissues into organs and organs into systems.</p> <p><b>Students should be able to</b> apply their knowledge of these features in explaining adaptations of eukaryotic cells.</p>	

### 3.2.1.2 Structure of prokaryotic cells and of viruses

Content	Opportunities for skills development
<p>Prokaryotic cells are much smaller than eukaryotic cells. ### 3.2.2 All cells arise from other cells

Content	Opportunities for skills development

### 3.2.3 Transport across cell membranes

Content	Opportunities for skills development
<p>The basic structure of all cell membranes, including cell-surface membranes and the membranes around the cell organelles of eukaryotes, is the same.</p> <p>The arrangement and any movement of phospholipids, proteins, glycoproteins and glycolipids in the fluid-mosaic model of membrane structure. ## 3.3 Organisms exchange substances with their environment

The internal environment of a cell or organism is different from its external environment. The exchange of substances between the internal and external environments takes place at exchange surfaces. To truly enter or leave an organism, most substances must cross cell plasma membranes.

In large multicellular organisms, the immediate environment of cells is some form of tissue fluid. Most cells are too far away from exchange surfaces, and from each other, for simple diffusion alone to maintain the composition of tissue fluid within a suitable metabolic range. In large organisms, exchange surfaces are associated with mass transport systems that carry substances between the exchange surfaces and the rest of the body and between parts of the body. Mass transport maintains the final diffusion gradients that bring substances to and from the cell membranes of individual cells. It also helps to maintain the relatively stable environment that is tissue fluid.

### 3.3.1 Surface area to volume ratio

Content	Opportunities for skills development

### 3.3.2 Gas exchange

### 3.3.3 Digestion and absorption

### 3.3.4 Mass transport

Over large distances, efficient movement of substance to and from exchange surfaces is provided by mass transport.

#### 3.3.4.1 Mass transport in animals

### 3.3.4.2 Mass transport in plants

Content	Opportunities for skills development
<p>Xylem as the tissue that transports water in the stem and leaves of plants. The cohesion-tension theory of water transport in the xylem.</p> <p>Phloem as the tissue that transports organic substances in plants. The mass flow hypothesis for the mechanism of translocation in plants. The use of tracers and ringing experiments to investigate transport in plants.</p> <p><b>Students should be able to:</b></p> <ul style="list-style-type: none"> <li>• recognise correlations and causal relationships</li> <li>• interpret evidence from tracer and ringing experiments and to evaluate the evidence for and against the mass flow hypothesis.</li> </ul>	<p><b>AT b</b></p> <p>Students could set up and use a potometer to investigate the effect of a named environmental variable on the rate of transpiration.</p>

## 3.4 Genetic information, variation and relationships between organisms

Biological diversity – biodiversity – is reflected in the vast number of species of organisms, in the variation of individual characteristics within a single species and in the variation of cell types within a single multicellular organism.

Differences between species reflect genetic differences. Differences between individuals within a species could be the result of genetic factors, of environmental factors, or a combination of both.

A gene is a section of DNA located at a particular site on a DNA molecule, called its locus. The base sequence of each gene carries the coded genetic information that determines the sequence of amino acids during protein synthesis. The genetic code used is the same in all organisms, providing evidence for evolution.

Genetic diversity within a species can be caused by gene mutation, chromosome mutation or random factors associated with meiosis and fertilisation. This genetic diversity is acted upon by natural selection, resulting in species becoming better adapted to their environment.

Variation within a species can be measured using differences in the base sequence of DNA or in the amino acid sequence of proteins.

Biodiversity within a community can be measured using species richness and an index of diversity.

### 3.4.1 DNA, genes and chromosomes

Content	Opportunities for skills development
<p>In prokaryotic cells, DNA molecules are short, circular and not associated with proteins.</p> <p>In the nucleus of eukaryotic cells, DNA molecules are very long, linear and associated with proteins, called histones. Together a DNA molecule and its associated proteins form a chromosome.</p> <p>The mitochondria and chloroplasts of eukaryotic cells also contain DNA which, like the DNA of prokaryotes, is short, circular and not associated with protein.</p> <p>A gene is a base sequence of DNA that codes for:</p> <ul style="list-style-type: none"> <li>• the amino acid sequence of a polypeptide</li> <li>• a functional RNA (including ribosomal RNA and tRNAs).</li> </ul> <p>A gene occupies a fixed position, called a locus, on a particular DNA molecule.</p> <p>A sequence of three DNA bases, called a triplet, codes for a specific amino acid. There are, for example, non-coding multiple repeats of base sequences between genes. Even within a gene only some sequences, called exons, code for amino acid sequences. Within the gene, these exons are separated by one or more non-coding sequences, called introns.</p>	



### 3.4.2 DNA and protein synthesis

Content	Opportunities for skills development
<p>The concept of the genome as the complete set of genes in a cell and of the proteome as the full range of proteins that a cell is able to produce.</p> <p>The structure of molecules of messenger RNA (mRNA) and of transfer RNA (tRNA).</p> <p>Transcription as the production of mRNA from DNA. The role of RNA polymerase in joining mRNA nucleotides.</p> <ul style="list-style-type: none"> <li>• In prokaryotes, transcription results directly in the production of mRNA from DNA.</li> <li>• In eukaryotes, transcription results in the production of pre-mRNA; this is then spliced to form mRNA.</li> </ul> <p>Translation as the production of polypeptides from the sequence of codons carried by mRNA. ### 3.4.3 Genetic diversity can arise as a result of mutation or during meiosis

<p>Gene mutations involve a change in the base sequence of chromosomes. They can arise spontaneously during DNA replication and include base deletion and base substitution. Due to the degenerate nature of the genetic code, not all base substitutions cause a change in the sequence of encoded amino acids. ### 3.4.4 Genetic diversity and adaptation

Content	Opportunities for skills development
<p>Genetic diversity as the number of different alleles of genes in a population.</p> <p>Genetic diversity is a factor enabling natural selection to occur.</p> <p>The principles of natural selection in the evolution of populations.</p> <ul style="list-style-type: none"> <li>• Random mutation can result in new alleles of a gene.</li> <li>• Many mutations are harmful but, in certain environments, the new allele of a gene might benefit its possessor, leading to increased reproductive success.</li> <li>• The advantageous allele is inherited by members of the next generation.</li> <li>• As a result, over many generations, the new allele increases in frequency in the population.</li> </ul> <p>Directional selection, exemplified by antibiotic resistance in bacteria, and stabilising selection, exemplified by human birth weights.</p> <p>Natural selection results in species that are better adapted to their environment. ### 3.4.5 Species and taxonomy

Content	Opportunities for skills development
<p>Two organisms belong to the same species if they are able to produce fertile offspring. Courtship behaviour as a necessary precursor to successful mating. The role of courtship in species recognition.</p> <p>A phylogenetic classification system attempts to arrange species into groups based on their evolutionary origins and relationships. It uses a hierarchy in which smaller groups are placed within larger groups, with no overlap between groups. Each group is called a taxon (plural taxa).</p> <p>One hierarchy comprises the taxa: domain, kingdom, phylum, class, order, family, genus and species.</p> <p>Each species is universally identified by a binomial consisting of the name of its genus and species, eg, <i>Homo sapiens</i>.</p> <p>Recall of different taxonomic systems, such as the three domain or five kingdom systems, will <b>not</b> be required.</p> <p><b>Students should be able to</b> appreciate that advances in immunology and genome sequencing help to clarify evolutionary relationships between organisms.</p>	

### 3.4.6 Biodiversity within a community

<p>Biodiversity can relate to a range of habitats, from a small local habitat to the Earth.</p> <p>Species richness is a measure of the number of different species in a community.</p> <p>An index of diversity describes the relationship between the number of species in a community and the number of individuals in each species.</p> <p>Calculation of an index of diversity (<math>d</math>) from the formula</p> $d = \frac{N(N-1)}{\sum n(n-1)}$ <p>where <math>N</math> = total number of organisms of all species and <math>n</math> = total number of organisms of each species.</p> <p>Farming techniques reduce biodiversity. ### 3.4.7 Investigating diversity

Content	Opportunities for skills development

## 3.5 Energy transfers in and between organisms (A-level only)

Life depends on continuous transfers of energy.

In photosynthesis, light is absorbed by chlorophyll and this is linked to the production of ATP.

In respiration, various substances are used as respiratory substrates. The hydrolysis of these respiratory substrates is linked to the production of ATP.

In both respiration and photosynthesis, ATP production occurs when protons diffuse down an electrochemical gradient through molecules of the enzyme ATP synthase, embedded in the membranes of cellular organelles.

The process of photosynthesis is common in all photoautotrophic organisms and the process of respiration is common in all organisms, providing indirect evidence for evolution.

In communities, the biological molecules produced by photosynthesis are consumed by other organisms, including animals, bacteria and fungi. Some of these are used as respiratory substrates by these consumers.

Photosynthesis and respiration are not 100% efficient. The transfer of biomass and its stored chemical energy in a community from one organism to a consumer is also not 100% efficient.

### 3.5.1 Photosynthesis (A-level only)

### 3.5.2 Respiration (A-level only)

Content	Opportunities for skills development
<p>Respiration produces ATP.</p> <p>Glycolysis is the first stage of anaerobic and aerobic respiration. ### 3.5.3 Energy and ecosystems (A-level only)

Content	Opportunities for skills development
<p>In any ecosystem, plants synthesise organic compounds from atmospheric, or aquatic, carbon dioxide.</p> <p>Most of the sugars synthesised by plants are used by the plant as respiratory substrates. The rest are used to make other groups of biological molecules. These biological molecules form the biomass of the plants.</p> <p>Biomass can be measured in terms of mass of carbon or dry mass of tissue per given area. ## 3.6 Organisms respond to changes in their internal and external environments (A-level only)

A stimulus is a change in the internal or external environment. A receptor detects a stimulus. A coordinator formulates a suitable response to a stimulus. An effector produces a response.

Receptors are specific to one type of stimulus.

Nerve cells pass electrical impulses along their length. A nerve impulse is specific to a target cell only because it releases a chemical messenger directly onto it, producing a response that is usually rapid, short-lived and localised.

In contrast, mammalian hormones stimulate their target cells via the blood system. They are specific to the tertiary structure of receptors on their target cells and produce responses that are usually slow, long-lasting and widespread.

Plants control their response using hormone-like growth substances.

### 3.6.1 Stimuli, both internal and external, are detected and lead to a response (A-level only)

## 3.7 Genetics, populations, evolution and ecosystems (A-level only)

The theory of evolution underpins modern Biology. All new species arise from an existing species. This results in different species sharing a common ancestry, as represented in phylogenetic classification. Common ancestry can explain the similarities between all living organisms, such as common chemistry (eg all proteins made from the same 20 or so amino acids), physiological pathways (eg anaerobic respiration), cell structure, DNA as the genetic material and a 'universal' genetic code.

The individuals of a species share the same genes but (usually) different combinations of alleles of these genes. An individual inherits alleles from their parent or parents.

A species exists as one or more populations. There is variation in the phenotypes of organisms in a population, due to genetic and environmental factors. Two forces affect genetic variation in populations: genetic drift and natural selection. Genetic drift can cause changes in allele frequency in small populations. Natural selection occurs when alleles that enhance the fitness of the individuals that carry them rise in frequency. A change in the allele frequency of a population is evolution.

If a population becomes isolated from other populations of the same species, there will be no gene flow between the isolated population and the others. This may lead to the accumulation of genetic differences in the isolated population, compared with the other populations. These differences may ultimately lead to organisms in the isolated population becoming unable to breed and produce fertile offspring with organisms from the other populations. This reproductive isolation means that a new species has evolved.

Populations of different species live in communities. Competition occurs within and between these populations for the means of survival. Within a single community, one population is affected by other populations, the biotic factors, in its environment. Populations within communities are also affected by, and in turn affect, the abiotic (physicochemical) factors in an ecosystem.

### 3.7.1 Inheritance (A-level only)

### 3.7.3 Evolution may lead to speciation (A-level only)

### 3.7.4 Populations in ecosystems (A-level only)

Content	Opportunities for skills development
<p>Populations of different species form a community. A community and the non-living components of its environment together form an ecosystem. Ecosystems can range in size from the very small to the very large.</p> <p>Within a habitat, a species occupies a niche governed by adaptation to both abiotic and biotic conditions.</p> <p>An ecosystem supports a certain size of population of a species, called the carrying capacity. ## 3.8 The control of gene expression (A-level only)

Cells are able to control their metabolic activities by regulating the transcription and translation of their genome. Although the cells within an organism carry the same coded genetic information, they translate only part of it. In multicellular organisms, this control of translation enables cells to have specialised functions, forming tissues and organs.

There are many factors that control the expression of genes and, thus, the phenotype of organisms. Some are external, environmental factors, others are internal factors. The expression of genes is not as simple as once thought, with epigenetic regulation of transcription being increasingly recognised as important.

Humans are learning how to control the expression of genes by altering the epigenome, and how to alter genomes and proteomes of organisms. This has many medical and technological applications.

Consideration of cellular control mechanisms underpins the content of this section. Students who have studied it should develop an understanding of the ways in which organisms and cells control their activities. This should lead to an appreciation of common ailments resulting from a breakdown of these control mechanisms and the use of DNA technology in the diagnosis and treatment of human diseases.

### 3.8.1 Alteration of the sequence of bases in DNA can alter the structure of proteins (A-level only)

Content	Opportunities for skills development
<p>Gene mutations might arise during DNA replication. They include addition, deletion, substitution, inversion, duplication and translocation of bases.</p> <p>Gene mutations occur spontaneously. The mutation rate is increased by mutagenic agents. Mutations can result in a different amino acid sequence in the encoded polypeptide.</p> <ul style="list-style-type: none"> <li>• Some gene mutations change only one triplet code. Due to the degenerate nature of the genetic code, not all such mutations result in a change to the encoded amino acid.</li> <li>• Some gene mutations change the nature of all base triplets downstream from the mutation, ie result in a frame shift.</li> </ul> <p><b>Students should be able to</b> relate the nature of a gene mutation to its effect on the encoded polypeptide.</p>	

## 3.8.2 Gene expression is controlled by a number of features (A-level only)

### 3.8.2.1 Most of a cell's DNA is not translated (A-level only)

<p>Totipotent cells can divide and produce any type of body cell.</p> <p>During development, totipotent cells translate only part of their DNA, resulting in cell specialisation.</p> <p>Totipotent cells occur only for a limited time in early mammalian embryos.</p> <p>Pluripotent cells are found in embryos; multipotent and unipotent cells are found in mature mammals and can divide to form a limited number of different cell types.</p> <ul style="list-style-type: none"> <li>• Pluripotent stem cells can divide in unlimited numbers and can be used in treating human disorders.</li> <li>• Unipotent cells, exemplified by the formation of cardiomyocytes.</li> <li>• Induced pluripotent stem cells (iPS cells) can be produced from adult somatic cells using appropriate protein transcription factors.</li> </ul> <p><b>Students should be able to</b> evaluate the use of stem cells in treating human disorders.</p>	<p><b>AT i</b></p> <p>Students could produce tissue cultures of explants of cauliflower (<i>Brassica oleracea</i>).</p>

### 3.8.2.2 Regulation of transcription and translation (A-level only)

Content	Opportunities for skills development
<p>In eukaryotes, transcription of target genes can be stimulated or inhibited when specific transcriptional factors move from the cytoplasm into the nucleus. The role of the steroid hormone, oestrogen, in initiating transcription.</p> <p>Epigenetic control of gene expression in eukaryotes.</p> <p>Epigenetics involves heritable changes in gene function, without changes to the base sequence of DNA. These changes are caused by changes in the environment that inhibit transcription by:</p> <ul style="list-style-type: none"> <li>• increased methylation of the DNA or</li> <li>• decreased acetylation of associated histones.</li> </ul> <p>The relevance of epigenetics on the development and treatment of disease, especially cancer.</p> <p>In eukaryotes and some prokaryotes, translation of the mRNA produced from target genes can be inhibited by RNA interference (RNAi).</p> <p><b>Students should be able to:</b></p> <ul style="list-style-type: none"> <li>• interpret data provided from investigations into gene expression</li> <li>• evaluate appropriate data for the relative influences of genetic and environmental factors on phenotype.</li> </ul>	

### 3.8.2.3 Gene expression and cancer (A-level only)

Content	Opportunities for skills development
<p>The main characteristics of benign and malignant tumours.</p> <p>The role of the following in the development of tumours:</p> <ul style="list-style-type: none"> <li>• tumour suppressor genes and oncogenes</li> <li>• abnormal methylation of tumour suppressor genes and oncogenes</li> <li>• increased oestrogen concentrations in the development of some breast cancers.</li> </ul> <p><b>Students should be able to:</b></p> <ul style="list-style-type: none"> <li>• evaluate evidence showing correlations between genetic and environmental factors and various forms of cancer</li> <li>• interpret information relating to the way in which an understanding of the roles of oncogenes and tumour suppressor genes could be used in the prevention, treatment and cure of cancer.</li> </ul>	

### 3.8.3 Using genome projects (A-level only)

Content	Opportunities for skills development
<p>Sequencing projects have read the genomes of a wide range of organisms, including humans.</p> <p>Determining the genome of simpler organisms allows the sequences of the proteins that derive from the genetic code (the proteome) of the organism to be determined. This may have many applications, including the identification of potential antigens for use in vaccine production.</p> <p>In more complex organisms, the presence of non-coding DNA and of regulatory genes means that knowledge of the genome cannot easily be translated into the proteome.</p> <p>Sequencing methods are continuously updated and have become automated.</p>	

### 3.8.4 Gene technologies allow the study and alteration of gene function allowing a better understanding of organism function and the design of new industrial and medical processes (A-level only)

#### 3.8.4.1 Recombinant DNA technology (A-level only)

Content	Opportunities for skills development
<p>Recombinant DNA technology involves the transfer of fragments of DNA from one organism, or species, to another. Since the genetic code is universal, as are transcription and translation mechanisms, the transferred DNA can be translated within cells of the recipient (transgenic) organism.</p> <p>Fragments of DNA can be produced by several methods, including:</p> <ul style="list-style-type: none"> <li>• conversion of mRNA to complementary DNA (cDNA), using reverse transcriptase</li> <li>• using restriction enzymes to cut a fragment containing the desired gene from DNA</li> <li>• creating the gene in a 'gene machine'.</li> </ul> <p>Fragments of DNA can be amplified by <i>in vitro</i> and <i>in vivo</i> techniques.</p> <p>The principles of the polymerase chain reaction (PCR) as an <i>in vitro</i> method to amplify DNA fragments.</p> <p>The culture of transformed host cells as an <i>in vivo</i> method to amplify DNA fragments.</p> <ul style="list-style-type: none"> <li>• The addition of promoter and terminator regions to the fragments of DNA.</li> <li>• The use of restriction endonucleases and ligases to insert fragments of DNA into vectors. Transformation of host cells using these vectors.</li> <li>• The use of marker genes to detect genetically modified (GM) cells or organisms. (Students will <b>not</b> be required to recall specific marker genes in a written paper.)</li> </ul> <p><b>Students should be able to:</b></p> <ul style="list-style-type: none"> <li>• interpret information relating to the use of recombinant DNA technology</li> <li>• evaluate the ethical, financial and social issues associated with the use and ownership of recombinant DNA technology in agriculture, in industry and in medicine</li> <li>• balance the humanitarian aspects of recombinant DNA technology with the opposition from environmentalists and anti-globalisation activists</li> <li>• relate recombinant DNA technology to gene therapy.</li> </ul>	<p><b>AT g</b></p> <p>Students could investigate the specificity of restriction enzymes using extracted DNA and electrophoresis.</p>



### 3.8.4.2 Differences in DNA between individuals of the same species can be exploited for identification and diagnosis of heritable conditions (A-level only)

Content	Opportunities for skills development
<p>The use of labelled DNA probes and DNA hybridisation to locate specific alleles of genes.</p> <p>The use of labelled DNA probes that can be used to screen patients for heritable conditions, drug responses or health risks.</p> <p>The use of this information in genetic counselling and personalised medicine.</p> <p><b>Students should be able to</b> evaluate information relating to screening individuals for genetically determined conditions and drug responses.</p>	

### 3.8.4.3 Genetic fingerprinting (A-level only)

Content	Opportunities for skills development
<p>An organism's genome contains many variable number tandem repeats (VNTRs). The probability of two individuals having the same VNTRs is very low.</p> <p>The technique of genetic fingerprinting in analysing DNA fragments that have been cloned by PCR, and its use in determining genetic relationships and in determining the genetic variability within a population.</p> <p>The use of genetic fingerprinting in the fields of forensic science, medical diagnosis, animal and plant breeding.</p> <p><b>Students should be able to:</b></p> <ul style="list-style-type: none"> <li>• explain the biological principles that underpin genetic fingerprinting techniques</li> <li>• interpret data showing the results of gel electrophoresis to separate DNA fragments</li> <li>• explain why scientists might use genetic fingerprinting in the fields of forensic science, medical diagnosis, animal and plant breeding.</li> </ul>	<p><b>AT g</b></p> <p>Students could use gel electrophoresis to produce 'fingerprints' of food dyes.</p>

# 4 Scheme of assessment

The AS specification is designed to be taken over one or two years with all assessments taken at the end of the course. The A-level specification is designed to be taken over two years with all assessments taken at the end of the course.

Assessments and certification for the AS specification are available for the first time in May/June 2016 and then every May/June for the life of the specification.

Assessments and certification for the A-level specification are available for the first time in May/June 2017 and then every May/June for the life of the specification.

These are linear qualifications. In order to achieve the award, students must complete all exams in May/June in a single year. All assessments must be taken in the same series.

Questions for these specifications will be set which require students to demonstrate:

- their knowledge and understanding of the content developed in one section or topic, including the associated mathematical and practical skills or
- the ability to apply mathematical and practical skills to areas of content they are not normally developed in or
- the ability to draw together different areas of knowledge and understanding within one answer.

A range of question types will be used, including those that require extended responses. Extended response questions will allow students to demonstrate their ability to construct and develop a sustained line of reasoning which is coherent, relevant, substantiated and logically structured. Extended responses may be in written English, extended calculations, or a combination of both, as appropriate to the question.

All materials are available in English only.

## 4.1 Aims

Courses based on these specifications should encourage students to:

- develop essential knowledge and understanding of different areas of the subject and how they relate to each other
- develop and demonstrate a deep appreciation of the skills, knowledge and understanding of scientific methods
- develop competence and confidence in a variety of practical, mathematical and problem solving skills
- develop their interest in and enthusiasm for the subject, including developing an interest in further study and careers associated with the subject
- understand how society makes decisions about scientific issues and how the sciences contribute to the success of the economy and society.

## 4.2 Assessment objectives

Assessment objectives (AOs) are set by Ofqual and are the same across all AS and A-level Biology specifications and all exam boards.

The exams will measure how students have achieved the following assessment objectives.

- AO1: Demonstrate knowledge and understanding of scientific ideas, processes, techniques and procedures
- AO2: Apply knowledge and understanding of scientific ideas, processes, techniques and procedures:
  - in a theoretical context
  - in a practical context
  - when handling qualitative data
  - when handling quantitative data
- AO3: Analyse, interpret and evaluate scientific information, ideas and evidence, including in relation to issues, to:
  - make judgements and reach conclusions
  - develop and refine practical design and procedures.

## 5.1 Entries and codes

You only need to make one entry for each qualification.

Every specification is given a national discount (classification) code by the Department for Education (DfE), which indicates its subject area.

If a student takes two specifications with the same discount code, Further and Higher Education providers are likely to take the view that they have only achieved one of the two qualifications. Please check this before your students start their course.

## 5.2 Overlaps with other qualifications

There is overlapping content in the AS and A-level Biology specifications. This helps you teach the AS and A-level together.

## 5.3 Awarding grades and reporting results

The AS qualification will be graded on a five-point scale: A, B, C, D and E.

The A-level qualification will be graded on a six-point scale: A\*, A, B, C, D and E.

Students who fail to reach the minimum standard for grade E will be recorded as U (unclassified) and will not receive a qualification certificate.

## 5.4 Re-sits and shelf life

Students can re-sit the qualifications as many times as they wish, within the shelf life of the qualifications.

## 5.5 Previous learning and prerequisites

There are no previous learning requirements. Any requirements for entry to a course based on these specifications are at the discretion of schools and colleges.

However, we recommend that students should have the skills and knowledge associated with at least GCSE Science and Additional Science or GCSE Biology (or equivalent qualifications).

## 5.6 Access to assessment: diversity and inclusion

General qualifications are designed to prepare students for a wide range of occupations and further study. Therefore our qualifications must assess a wide range of competences.

The subject criteria have been assessed to see if any of the skills or knowledge required present any possible difficulty to any students, whatever their ethnic background, religion, sex, age, disability or sexuality. If any difficulties were encountered, the criteria were reviewed again to make sure that tests of specific competences were only included if they were important to the subject.

As members of the Joint Council for Qualifications (JCQ) we participate in the production of the JCQ document *Access Arrangements and Reasonable Adjustments: General and Vocational qualifications*. We follow these guidelines when assessing the needs of individual students who may require an access arrangement or reasonable adjustment. ### Students with disabilities and special needs

We can make arrangements for disabled students and students with special needs to help them access the assessments, as long as the competences being tested are not changed. # 6 Mathematical requirements and exemplifications

In order to be able to develop their skills, knowledge and understanding in Biology, students need to have been taught, and to have acquired competence in, the appropriate areas of mathematics as indicated in the table of coverage below.

Overall, at least 10% of the marks in assessments for biology will require the use of mathematical skills. These skills will be applied in the context of biology and will be at least the standard of higher tier GCSE mathematics.

The following tables illustrate where these mathematical skills may be developed during teaching or could be assessed. Those shown in **bold type** would only be tested in the full A-level course.

This list of examples is not exhaustive. These skills could be developed or assessed in other areas of specification content. Other areas where these skills could be developed have been exemplified throughout these specifications.

# 7 AS practical assessment

Practical work is at the heart of biology, so we have placed it at the heart of this specification.

Assessment of practical skills in this AS specification will be by written exams only.

The practical endorsement does not apply to the AS specification. A rich diet of practical work is essential to develop students' manipulative skills and understanding of the processes of scientific investigation. It also contributes to teaching and learning of the concepts within this specification.

Questions in the papers have been written in the expectation that students have carried out at least the six required practical activities in section 7.2.

15% of the marks in the papers will relate to practical work.

## 7.1. Use of apparatus and techniques

All students taking this specification are expected to have carried out the required practical activities in section 7.2. These develop skills in the use of many of the following apparatus and techniques. This list is a compulsory element of the full A-level course. It is reproduced here for reference and to aid co-teaching the AS and A-level specifications.

This list is not designed to limit the practical activities carried out by students. A rich practical experience for students will include more than the six required practical activities. The explicit teaching of practical skills will build students' competence. Many teachers will also use practical approaches to the introduction of content knowledge in the course of their normal teaching.

Overall, at least 15% of the marks for an AS Biology qualification will require the assessment of practical skills.

# 8 A-level practical assessment

Practical work is at the heart of biology, so we have placed it at the heart of this specification.

Practical assessments have been divided into those that can be assessed in written exams and those that can only be directly assessed whilst students are carrying out experiments.

A-level grades will be based only on marks from written exams.

A separate endorsement of practical skills will be taken alongside the A-level. This will be assessed by teachers and will be based on direct observation of students' competency in a range of skills that are not assessable in written exams.

## 8.1 Use of apparatus and techniques

All students taking an A-level Biology qualification are expected to have had opportunities to use the following apparatus and develop and demonstrate these techniques. These apparatus and techniques are common to all A-level Biology specifications.

Carrying out the 12 required practicals in section 8.2 means that students will have experienced use of each of these apparatus and techniques. However, teachers are encouraged to develop students' abilities by inclusion of other opportunities for skills development, as exemplified in the right-hand column of the content section of this specification.

## 8.4 A-level practical skills to be assessed via endorsement

### 8.4.1 Cross-board statement on practical endorsement

The assessment of practical skills is a compulsory requirement of the course of study for A-level qualifications in biology, chemistry and physics. It will appear on all students' certificates as a separately reported result, alongside the overall grade for the qualification. The arrangements for the assessment of practical skills will be common to all awarding organisations. These arrangements will include:

- A minimum of 12 practical activities to be carried out by each student which, together, meet the requirements of Appendices 5b (Practical skills identified for direct assessment and developed through teaching and learning) and 5c (Use of apparatus and techniques) from the prescribed subject content, published by the Department for Education. The required practical activities will be defined by each awarding organisation.
- Teachers will assess students against Common Practical Assessment Criteria (CPAC) issued jointly by the awarding organisations. The CPAC (see below) are based on the requirements of Appendices 5b and 5c of the subject content requirements published by the Department for Education, and define the minimum standard required for the achievement of a pass.
- Each student will keep an appropriate record of their practical work, including their assessed practical activities.
- Students who demonstrate the required standard across all the requirements of the CPAC will receive a 'pass' grade.
- There will be no separate assessment of practical skills for AS qualifications.
- Students will answer questions in the AS and A-level examination papers that assess the requirements of Appendix 5a (Practical skills identified for indirect assessment and developed through teaching and learning) from the prescribed subject content, published by the Department for Education. These questions may draw on, or range beyond, the practical activities included in the specification.
