## Section A

Answer Question 01.

## Source A

From a letter from the Imperial Ambassador in London, Eustace Chapuys, to the Holy Roman Emperor Charles V, January 1531. The letter reports his discussion with the Duke of Norfolk, a leading Privy Councillor and uncle of Anne Boleyn.

I said that the Pope had fulfilled the King's wishes as much as he could in the matter of the annulment. The Duke referred to calling the General Council of the Church; I remarked that the Pope had been unwilling to call the Council because of the lies Henry had published about him, whereas the Pope had given the King no occasion to do anything against him or the Church.

The Duke of Norfolk said that the Pope had no jurisdiction, except in matters of heresy and that the Pope had tried to usurp the King's authority. He stated that the King had a right to Empire and that he recognised no superior.

## Source B

From the Act passed by parliament in 1534 for the submission of the clergy to the King. This confirmed in law the submission which the clergy had made to Henry VIII in May 1532 when they had been accused of Praemunire.

The King's humble and obedient subjects the clergy, submitting themselves to the King's Majesty, have promised that they will never from henceforth attempt, allege, claim or put in use, or enact any new canon law, unless his Majesty does give his most royal assent and authority.

And be it further enacted, that no appeals shall be made out of this realm to the Bishop of Rome. All appeals in cases of matrimony and tithes shall be made within this realm.

If any persons make any manner of appeals to the Bishop of Rome, then such persons will incur the penalties contained in the Act of Praemunire passed in the reign of Richard II.
