Source A

From a speech delivered in the Senate by Mississippi Senator, James Eastland, 27 May 1954. Eastland was speaking after the Brown v Board of Education decision in the Supreme Court.

Segregation is not a badge of racial inferiority. Segregation is desired and supported by the vast majority of both races in the South, who live side by side under harmonious conditions.

We take pride in the constant advance the negro has made in the South. It is on social questions that Southern people draw the line and with these they will not permit the Supreme Court to interfere. 5

All free men have the right to associate exclusively with their own race, free from governmental interference. Free men have the right to send their children to schools of their own choosing, free from governmental interference. These rights are established in the Constitution and in the American system of government. 10
