Section AAnswer Question 01.

Source A

From a letter from New York merchants to the Boston Committee of Correspondence, 23 May 1774. This responded to a request for a ban on trade with Britain after the 1774 Intolerable Acts.

We, the merchants of New York, believe the alarming measures of the British Parliament fill the inhabitants of this city with inexpressible concern. As a sister colony, we consider your punishment as a common cause, and it is both our duty and our interest to contribute to the cancellation of this. But exactly what ought to be done in a situation so truly critical is very hard to determine.

We conclude that a congress of deputies from the colonies should be assembled without delay, and some unanimous resolution formed. Therefore, it would be premature to make any decision on the line of action you propose. However, please do us the justice of believing that we shall continue to act with a firm regard for American freedom.

Source B

From an anonymous leaflet, entitled 'Join or Die', circulated in late May 1774 in Newport, Rhode Island. Rhode Island was a colony near Boston.

The Act blocking Boston harbour is believed to be infinitely more alarming and dangerous to our common liberties than even that evil monster, the Stamp Act (which was defeated by our firmness and union). This Act must be read with indignation by every real friend of freedom in Europe and America.

Though Boston is the immediate target, the insult and indignity offered to our virtuous brethren there ought to be viewed as a direct, hostile invasion of every province on the continent. The generals of tyranny are now preparing to attack our defences; nothing but unity, resolution, resistance and perseverance can save us from slavery!
