Alternatively, functionalists argue that the family performs vital functions for the whole of society. For example, family members benefit from the support and emotional satisfaction that they give each other.

Alternatively, the idea of the social construction of disability is that a person may have an impairment of some kind. However, this impairment only becomes a disability as a result of the way in which society is organised and responds to the impairment.

However, there are some social groups that may choose not to work, or may not need to work. For these groups, worklessness can be a positive experience.
