**PUBLISHED****Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptions for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.


**Annotations guidance for centres**

Examiners use a system of annotations as a shorthand for communicating their marking decisions to one another. Examiners are trained during the standardisation process on how and when to use annotations. The purpose of annotations is to inform the standardisation and monitoring processes and guide the supervising examiners when they are checking the work of examiners within their team. The meaning of annotations and how they are used is specific to each component and is understood by all examiners who mark the component.

We publish annotations in our mark schemes to help centres understand the annotations they may see on copies of scripts. Note that there may not be a direct correlation between the number of annotations on a script and the mark awarded. Similarly, the use of an annotation may not be an indication of the quality of the response.

Answers may include some of the following ideas. All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• The Bible is the holy book of Christianity, and Christians think of it as the word of God; having it present during worship enables them to experience their relationship with God more directly through God’s words to them.</li> <li>• The Bible contains information about the history of the religion, and the principles and values Christians should follow in their lives. Engaging with these is important for reflection on how to apply those teachings in their own lives.</li> <li>• Passages from the Bible can be read as prayers, or Christians can reflect on their meaning during meditation to help strengthen their faith or broaden their understanding.</li> <li>• While many of the elements of public and communal worship can only be found in churches, the Bible can be taken and read anywhere, enabling Christians to keep the word of God with them always.</li> </ul>	<b>6</b>

Answers may include some of the following ideas. Giving different views does not require presenting opposing or contradictory points. All valid material must be credited.</p> <ul data-bbox="336 523 1939 1040" style="list-style-type: none"> <li>• Statues often represent or illustrate important events in the history of the religion, teaching people what happened or creating emotional responses to those events.</li> <li>• Statues can help a Christian to focus on prayer or meditation; for example, a Crucifix might help them remember Jesus' sacrifice, while a statue of the Virgin Mary with an infant Jesus might remind them of the joy and hope inherent in the incarnation.</li> <li>• Statues of saints remind Christians of the work that they did for the Christian faith; they might also encourage Christians to emulate saintly virtues.</li> <li>• Both the symbolism and the beauty of works of art can encourage people to embrace the message of Christianity and be saved.</li> <li>• The beauty of works of art could be seen as a distraction from God and/or from the things which people should be focusing on while they are in church.</li> <li>• One of the Ten Commandments prohibits worshipping idols, and some Christians consider having statues in a church creates the risk that they will become idols, with people focusing on them instead of God.</li> <li>• Images of sacred things might be seen as limiting them or claiming knowledge about them that is not for human beings to have; many Christians would object to someone making a statue of God for this reason.</li> </ul>	8

Answers may include some of the following ideas. Giving different views does not require presenting opposing or contradictory points. All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• ‘God the Father’ is one of the persons of the Trinity, and therefore is a central aspect of understanding the nature of God for many Christians.</li> <li>• The Father is the part of God that most Christians believe was responsible for Creation, and it is also God the Father who sent Jesus to redeem humanity.</li> <li>• Belief in Jesus is the way people can be saved, but it is God the Father with whom Christians believe they need to be reconciled, because it is the Father they are separated from by sin.</li> <li>• For many Christians the relationship of God with humanity is parental in nature – nurturing, protecting and chastising where necessary in the child’s best interest.</li> <li>• The presence of God the Father is what makes heaven what it is.</li> </ul>	<b>6</b>

Your response should consider different points of view when you evaluate the question.</b></p> <p>Use Table B AO2 Evaluation to mark candidate responses to this question. Answers may include some of the following ideas. Giving different views does not require presenting opposing or contradictory points. All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• The three parts of the Trinity are Father, Son and Holy Spirit; they help Christians to understand the nature of God .</li> <li>• The Father is the creator, the Son is the redeemer and God’s incarnation on Earth, and the Holy Spirit is the power of God in the world now.</li> <li>• The concept that the Trinity is three distinct persons – who are coeternal, coequal, and indivisibly united in one being – is paradoxical. Accepting it as true, even though it can’t be fully grasped by reason or proven objectively, could be seen as a demonstration of faith, which is the most important virtue for many Christians.</li> <li>• Some Christians believe that the Bible teaches that God is a Trinity; while the doctrine is not set out in so many words, putting together everything that is said about God and Jesus leads to it.</li> <li>• The word ‘Trinity’ does not appear in the text of the Bible, while the statement that God is one is certainly there.</li> <li>• Some branches of Christianity are non-Trinitarian, or even anti-Trinitarian, because they believe the Trinity contradicts the idea of God being one.</li> <li>• Non-Trinitarian Christians might believe that viewing Jesus as God undermines the idea of him as a perfect man . This makes the ideal of living as he did less attainable for ordinary people and might even be felt to render his sacrifice meaningless.</li> <li>• Some Christians believe that the three aspects of Father, Son and Holy Spirit describe different ways that human beings can relate to God, rather than describing a single being with three natures.</li> </ul>	8

Answers may include some of the following ideas. All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• The Catholic church is based in Rome. The Pope lives there and he is the leader of the Catholic church, following in the footsteps of Saint Peter.</li> <li>• Pilgrims go to hear the Pope speak in St Peters Square or to attend a Mass led by him. Some might even have a personal audience with him.</li> <li>• St Peter’s Basilica and his tomb underneath it are important sites where Christians can feel connected to the history of their faith. There are also catacombs where Christians hid during times of persecution.</li> <li>• There are many churches connected with the founding of religious orders or with particular saints.</li> <li>• The Pontifical Sanctuary of the Holy Stairs, also called Pilate’s Stair, can be found in Rome. Traditionally these are said to be the stairs that Jesus stood on when he was brought to Pilate for trial. They were brought to Rome in the fourth century.</li> </ul>	<b>6</b>

3(c)	<p><b>Evaluate whether overcoming physical challenges is the most important part of Christian pilgrimage.</b></p> <p><b>You must refer to Christianity in your answer. Your response should consider different points of view when you evaluate the question.</b></p> <p>Use Table B AO2 Evaluation to mark candidate responses to this question. Answers may include some of the following ideas. Giving different views does not require presenting opposing or contradictory points. All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• Taking the time and making the physical effort for a pilgrimage shows an individual’s commitment to their religious life . This this could be considered as witnessing their faith to others, which Christians are commanded to do, or simply as showing their devotion to God.</li> <li>• Working the body hard and subjecting it to austerities has been seen in some Christian traditions as nourishing the spirit, enabling it to soar above the limitations of the flesh. This can also be connected with the idea of following in Jesus’ footsteps, suffering as he suffered.</li> <li>• Most pilgrimages are to places of significance in the history of the religion, meaning they involve being physically in the place where particular events happened. This means that the challenges of getting there are the same challenges as the people involved would have faced, helping the pilgrim feel closer to the event.</li> <li>• Pilgrimage is undertaken primarily for spiritual purposes and too much physical challenge could be said to distract someone from God, forcing them to focus on their bodily discomfort instead.</li> <li>• The whole experience of the pilgrimage involves the whole person, body and soul or spirit; neither can be considered more important than the other or meaningfully separated.</li> <li>• Setting aside time and physical luxury might help a person to identify and focus on what is really important but it is a means to an end, rather than the aim of the pilgrimage.</li> </ul>	8

4(b)	<p><b>Explain why the Prophet Muhammad (pbuh) was persecuted in Makkah.</b></p> <p>Use Table A AO1 Knowledge and understanding to mark candidate responses to this question. All valid material must be credited.</p> <p>Answers may include some of the following ideas.</p> <ul style="list-style-type: none"> <li>• The tribal religion in Makkah was polytheistic and involved worshipping idols, both of which Muhammad (pbuh) rejected publicly as being sinful.</li> <li>• Muhammad (pbuh) told the tribes that idol worship would result in punishment in hell, and this was seen as disrespecting the ancestors of the tribe.</li> <li>• Pilgrims travelled to Makkah to visit the Ka'bah and worship the idols inside it. They brought a lot of money into the city and made the ruling tribe powerful.</li> <li>• Muhammad (pbuh) accepted slaves into Islam as equals to free people, which their owners felt was inappropriate, threatening their way of life and risking making the slaves disobedient.</li> </ul>	<b>6</b>

4(c)	<p><b>Discuss the significance of the restrictions on Muslim life given in the Qur'an.</b></p> <p><b>You must refer to Islam in your answer. Your response should consider different points of view when you evaluate the question.</b></p> <p>Use Table B AO2 Evaluation to mark candidate responses to this question. Answers may include some of the following ideas. Giving different views does not require presenting opposing or contradictory points. All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• Religious rules and commandments can take the form of restrictions/prohibitions or they might be instructions on things someone has to do. Restrictions might be broader in scope or simpler to understand than instructions; e.g. being forbidden to eat meat that is not halal is simpler to grasp than the various requirements which would make it so.</li> <li>• The restrictions relate to natural drives which might lead someone to sin if they are not controlled; e.g. banning sex outside marriage ensures that this natural desire does not become oppressive, abusive or a distraction from God.</li> <li>• All societies place some restrictions on the people living within them as this allows many people to live close together without conflicts. Muslims believe Islam sets out the rules for an ideal society, pleasing to God.</li> <li>• The Five Pillars of Islam are considered the foundation of the religion and they are not expressed as restrictions but rather as things Muslims must do.</li> <li>• For someone who is focused on God and being a good Muslim, knowing what is not going to contribute to that is unlikely to feel like a restriction.</li> <li>• The prohibitions all relate to avoiding things that are harmful, so there is really only one restriction given.</li> <li>• All the words in the Qur'an are the words of God and they are all therefore equally important.</li> </ul>	8

All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• Many Muslims perform the Hajj every year and ihram shows that there is no distinction between them in the eyes of God.</li> <li>• Wearing ihram signifies that the Muslim is in a state of purity, having declared their intention to perform the Hajj and committed themselves to doing so in this pure state.</li> <li>• Wearing ihram also involves certain behavioural requirements, such as not cutting the hair or wearing perfume, meaning it is about far more than simple clothing.</li> <li>• Ihram refers not only to the clothing but also to the consecrated state the Muslim is in throughout their Hajj. Without this the Hajj will not be valid.</li> <li>• Other aspects without which the Hajj would not be considered valid include completing the stand at ‘Arafat or having the right intention from the outset.</li> <li>• While the state of ihram is universal for all Muslims on the Hajj, there is no special form of clothing required for women. The state might therefore be considered of greater significance than the wearing of the clothing although the clothing is more noticeable to an outside observer.</li> <li>• Ihram is an intrinsic part of the Hajj, which is a very significant experience in its entirety; no one part can really be singled out from this whole as being the most important.</li> </ul>	8

The mosque is the place where this unity is most clearly visible.</li> <li>• The first mosque was built immediately Muhammad (pbuh) arrived in Madinah, suggesting that a space for communal worship was highly valued.</li> <li>• A mosque ensures that Muslims can be educated about their religion and have somewhere to seek help and support from the community.</li> <li>• Muslims are instructed to pray together at the mosque on Fridays (Jummah prayer).</li> <li>• Muslims can pray anywhere clean, and should do so if they are not near a mosque when it is time for prayer. It is a light that is kept permanently burning in front of the Ark in a synagogue . It represents the light which was kept burning in the Temple in Jerusalem, the holiest place for Jews .</li> <li>• The light burned in the Temple by the command of G-d, and although the Temple is no longer there Jews might consider it important to show that they remember both the Temple and the instructions given regarding it .</li> <li>• The perpetual light is a symbol of the eternal presence of G-d and G-d's care for the Jewish people . It also reminds people of the holiness of the Torah scrolls within the Ark .</li> <li>• The ner tamid can be seen as a symbol of the Covenant relationship with G-d. The need to tend a flame in order to keep it burning is sometimes considered to symbolise the need to put effort into one's relationship with G-d and, although most synagogues no longer use an oil lamp, this remains a meaningful symbol.</li> </ul>	<b>6</b>

All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• Three daily prayer services are held in the synagogue; while Jews can perform these prayers alone there is a belief that they heard more readily by G-d when offered in congregation.</li> <li>• Worship is a mitzvah for Jews and some forms of worship require a minyan, meaning that a minimum number of adults must be present. This means that those forms of worship must be communal in order to fulfil the requirements set out by G-d.</li> <li>• Public worship helps people to feel part of their community, bringing everyone together, enabling them to share ideas and hear the teachings of their religion, and reminding them of their special relationship with G-d.</li> <li>• When a minyan is required but not possible, those present can still read the prayers for themselves and G-d will still hear them, so there is always an alternative to public prayer.</li> <li>• The Six Constant Mitzvot require Jews to always remember to love G-d, fear G-d and obey G-d's laws. This is as important during ordinary, everyday activities as it is when in the synagogue. However, remembering and obeying G-d could be said to inherently include those acts of communal worship which are part of the mitzvot.</li> <li>• Public worship is generally formal and follows a specific pattern; private worship is more flexible and allows Jews to cultivate a more personal sense of relationship with G-d.</li> </ul>	8

All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• Holocaust is an English word, derived from Greek, while Shoah is of Hebrew origin. Hebrew is the Jewish language and, since the Jewish people are a primary subject of the persecution being named, some might consider that their name is more appropriate than one given by others.</li> <li>• The original Greek from which the term Holocaust derives refers to burnt offerings made to the gods. This could be said to imply the people who died in the camps did so for a reason or a higher, maybe even a divine, purpose. Some survivors find this idea offensive and reject the term as a result.</li> <li>• As a Hebrew term, originating in the Torah, Shoah implies a focus on the Jewish victims of the Nazis, rather than the totality of those who suffered and died in the various camps and programmes that existed during Hitler’s rule.</li> <li>• While Jews do not wish to deny that other groups were persecuted, Jewish victims do make up the largest single group and therefore some prefer to use the Hebrew when speaking of the attempted genocide of the Jewish people.</li> </ul>	<b>6</b>

All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• There are three major festivals, known as the Pilgrim Festivals Passover, Shavuot and Sukkot. The Torah instructs Jews to travel to Jerusalem during these festivals, bringing offerings to the Temple.</li> <li>• Jerusalem is the site where the Jewish Temple stood and pilgrimage to the remaining fragment of that Temple enables Jews to connect with their history and the Covenant with G-d.</li> <li>• Other sites of significance in Jewish history are often viewed as places of pilgrimage, where Jews can remember the events and/or the people associated with them, and reflect on their meaning.</li> <li>• Pilgrimage to the Temple in the original sense commanded in the Torah is no longer possible, and therefore not carrying it out regularly is not viewed as disobedience to the mitzvot,</li> <li>• Most Jews do not physically travel anywhere during the Pilgrim Festivals, although there are some symbolic elements relating to travel such as the booths built during Sukkot. This implies that the spiritual meaning or benefit of participating in the festival is not dependent on the physical act of pilgrimage.</li> <li>• Pilgrimage to places other than the Temple is not a mitzvot but a personal choice, so its importance will be different for different individuals.</li> </ul>	8

Answers may include some of the following ideas. Giving different views does not require presenting opposing or contradictory points. All valid material must be credited.</p> <ul style="list-style-type: none"> <li>• Mitzvot can take the form of restrictions/prohibitions on what a person can do, or they can be instructions on things someone has to do. Restrictions might be simpler to understand than instructions, e.g. being forbidden to eat what is not kosher meat is simpler to grasp than the various requirements which would make something kosher.</li> <li>• As the Chosen People, Jews have rules to follow which don't apply to everyone else, including not doing things which others are allowed to do. This is an important part of the Covenant.</li> <li>• There are more negative mitzvot (365) than positive ones (248), which could be said to imply it is more important to know what to avoid or that there more things it is necessary to avoid.</li> <li>• All societies place some restrictions on the people living within them, as only this allows many people to live close together without conflict. Many of the restrictions placed on behaviour relate to the rights of other people and how they should be treated</li> <li>• The most significant mitzvot are the Six Constant Mitzvot, which Jews should always be conscious of. They are a mixture of things to do (know there is G-d) and things not to do (believe in other gods), implying that is not a particularly important distinction.</li> <li>• For someone who is focused on G-d and being a good Jew, knowing what is not going to contribute to that is unlikely to feel like a restriction.</li> <li>• All the mitzvot are from G-d and they are all therefore equally important.</li> </ul>	8
