**Tourism in Scotland**

Scotland, a country in the UK, has introduced a tourism tax. The tax will be applied to all overnight stays by tourists in Scotland. Many countries around the world already have a similar tax.

The tax is added to the price charged by all types of accommodation for every night a tourist stays.

The government in Scotland has said the money raised from the tax will be reinvested locally into facilities and services for visitors. They say this will make the tourist experience better and benefit local communities and the economy.

On average a plane emits 77 times more CO<sub>2</sub> per passenger than a train on the same route.

In France, tourism accounts for 8% of GDP and it has over 90 million tourists every year.
