The preparatory work must consist of not more than **four** sides of paper (two sheets) no larger than A1 size on which smaller works may be mounted. You may work on smaller paper if you choose.

This paper assesses your response to visual stimuli and involves direct observation from primary sources, recording, analysis and 2D and/or 3D development.

At the end of the examination, fasten all your work securely together at the top left-hand corner of each sheet.

All questions in this paper carry equal marks.

Choose **one** of the following questions from **any** section.

Record, analyse and develop your ideas from direct observation and personal experience.

Section A is appropriate for **any** Area of Study and may be chosen by **any** candidates, particularly those who prefer an open-ended starting point.

Section B is appropriate for **any** Area of Study and may be chosen by **any** candidates, particularly those who prefer a specific starting point.

Section C may **only** be chosen by candidates who prefer to be offered a specific design brief.

Section A

- 1 Weathered
- 2 Unusual viewpoint
- 3 Interwoven
- 4 Personal adornments
- 5 Shimmering
- 6 Exaggeration or distortion

Section B

- 7 Cakes, pastries or breads, some partly sliced, placed on a dish with a knife, near to a tea or coffee pot, cups and saucers or mugs.
- 8 A shirt, next to an upright iron, is on an ironing board or a table. Nearby is a basket of washing and a few already pressed items hanging on the back of a chair or stacked on the seat.
- 9 The whole or the upper half of a person, wearing a boldly patterned shirt or dress, seated next to a large potted plant.
- 10 A view of cars, trucks and motorcycles parked in the forecourt of a garage or a petrol station.

- 11 Interpret the whole or any part of this extract:

'The boats returned to the harbour at daybreak. Once the catch had been unloaded an auction was held in the covered market. As soon as the stallholders started to gut and display their fish, the first buyers from the local shops and restaurants began to arrive.'

Section C

- 12 Using the name of your region or country, design the cover for a travel brochure entitled '..... **NATIONAL PARK**' for a tour company named **Safari Holidays**.
- 13 Design a repeat pattern for a clothing fabric based on observations of at least **two** of the following: seaweed, coral, seashells, sea anemones, starfish, seahorses, jellyfish.
- 14 Design the costumes for two participants in a ballet based on the idea of toys, dolls and puppets being magically brought to life.
- 15 Using the initials **NGM** to represent a National Geological Museum, design the packaging for a specifically named geological specimen which can be purchased from the museum shop.
