**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however, the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

You may pass out.’ The café owner threw up her hands at the sight of me, then turned, alarmed, to shout at a couple of well-dressed gentlemen eating at a table in the corner.</b></p> <p><b>Award 3 marks</b> for an appropriate example with a comprehensive explanation which shows understanding of how the writer suggests the eating-place owner’s feelings.</p> <p><b>Award 2 marks</b> for an appropriate example and attempt at an explanation which shows some understanding of how the writer suggests the eating-place owner’s feelings.</p> <p><b>Award 1 mark</b> for an example with an attempt at an explanation which shows awareness of the eating-place owner’s feelings. The explanation may be partial.</p> <p>The explanation <b>must</b> be predominantly in the candidate’s own words.</p> <p><b>Responses <i>might</i> use the following:</b></p> <ul style="list-style-type: none"> <li>• <b>‘No! You mustn’t drink too much. Choose <u>three</u> examples of words or phrases from <u>each</u> paragraph to support your answer. Your choices should include the use of imagery.</b></p> <p><b>Write about 200 to 300 words.</b></p> <p><b><u>Up to 15 marks are available for the content of your answer.</u></b></p> <p>Use the Marking Criteria for Question 2(d) (Table A, Reading)</p> <p>Notes on task</p> <p>This question is marked for the ability to select powerful or unusual words and for an understanding of ways in which the language is effective. Expect responses to provide words / phrases that carry connotations additional to general meaning.</p> <p>Mark holistically for the overall quality of the response, not for the number of words chosen, bearing in mind that for the higher bands there should be a range of choices to demonstrate an understanding of how language works, and that this should include the ability to explain images. It is the quality of the analysis that attracts marks. Do not deduct marks for inaccurate statements; simply ignore them.</p> <p>The following notes are a guide to what good responses might say about the selections.</p> <p>Candidates can make any <i>sensible</i> comment, but only credit those that are relevant to the correct meanings of the words in the context and that have some validity. Alternative acceptable explanations should be credited. Credit comments on effects created by non-vocabulary choices such as grammar / syntax and punctuation devices. These must be additional to comments on vocabulary.</p>	15

2(d)	<p>Responses <i>might</i> use the following:</p> <ul style="list-style-type: none"> <li>• <b>Paragraph 2 begins ‘By mid-morning ...’ and is about the effect of the heat on the landscape and the speaker.</b></li> </ul> <p><i>Overview: the overpowering annihilating effect of the heat on the whole landscape.</i></p> <ul style="list-style-type: none"> <li>• <b>violence of the heat:</b> aggressively high temperatures, likely to cause injury, threatening, hostile, malevolent force, unbearable</li> <li>• <b>seemed to bruise the whole earth:</b> visible injury to the environment, unlimited reach of the heat, impact on the earth, pain, damaged</li> <li>• <b>turn its crust into one huge scar:</b> heat is so strong that the earth is reddened or completely burnt by its intensity, desiccated surface, permanent mark and damage</li> <li>• <b>the sun struck upwards, sideways and down:</b> the sun’s effect was felt in all directions, onslaught of punches, powerful force, no escaping its effect, unnatural</li> <li>• <b>buckling:</b> damaged by the heat, bent, warped, flattened by the constant assault of the sun, giving way, submitting</li> <li>• <b>like a solid sheet of copper:</b> darkened expanse of orange / brown metallic colour; made hard, brittle and flattened; shimmering as in a heat haze, mimics sheen of metal</li> <li>• <b>no shade to hide in:</b> empty landscape, no trees, barren, unforgiving</li> <li>• <b>the red-hot dust grinding like pepper (between my toes):</b> grating particles, harsh spicy heat that damages, uncomfortable, causing pain</li> </ul>

Use the following table to give a mark out of 15 for Reading.

<b>5</b>	<b>13–15</b>	<ul style="list-style-type: none"> <li>• Wide-ranging discussion of judiciously selected language with some high quality comments that add meaning and associations to words/phrases in both parts of the text, and demonstrate the writer's reasons for using them.</li> <li>• Tackles imagery with some precision and imagination.</li> <li>• There is clear evidence that the candidate understands how language works.</li> </ul>
<b>4</b>	<b>10–12</b>	<ul style="list-style-type: none"> <li>• Explanations are given of carefully selected words and phrases.</li> <li>• Explanations of meanings within the context of the text are secure and effects are identified in both parts of the text.</li> <li>• Images are recognised as such and the response goes some way to explaining them.</li> <li>• There is some evidence that the candidate understands how language works.</li> </ul>

3	<ul style="list-style-type: none"> <li>• <b>improved water provision / advise tourists to carry own water</b> (det. scarce natural water sources) [dev. replace wells with piped drinking water / healthier for the farm workers too]</li> <li>• <b>improved transport / publicise car-hire more effectively</b> (det. cheap and straightforward to hire a car) [dev. taxi / bus service]</li> <li>• <b>provide shade</b> (det. eucalyptus trees) [dev. would encourage tourists to split their journey up and not keep on walking]</li> <li>• <b>more support for the locals</b> (det. help tourists regularly; three tourists to deal with in a month; have to take to city in car) [dev. authority involvement / medical provision / transport provided / learn from the experience of café owners]</li> </ul>
