




# New high-rises set to transform Amman's skyline









# **Growing groundnuts**

Groundnuts are small, bushy plants. The seeds grow under the soil. Groundnuts are also called peanuts. They need temperatures of around 26°C and rainfall over 500 mm during the four to five months when the crop is growing. They grow best on light, welldrained soils.

# Growing rice

Rice is an important grain or cereal crop. It needs temperatures of over 21 °C during the five-month growing season, followed by a dry, sunny period for the crop to ripen. It needs a high rainfall, or large amounts of irrigation water. It grows best in rich, muddy soil.


