**Section A: The American Civil War, 1861–1865**

Study the Background Information below and then answer **all** the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

**Background Information**

The Civil War between Union and Confederate forces was extensive and highly destructive. Fighting was intense and brutal. Many battles were fought, of which some were particularly significant. As most military campaigns were conducted in the South, the Confederate States suffered a great deal. The blockade of the South by the Union Navy had important economic and military consequences.

**Part A: The War on Land and Sea**

You are advised to spend 1 hour in answering Questions 1 to 4.

**1 Study Source A**

What is the message of this cartoon? Explain your answer using details from the source **and** your knowledge. [6]

**2 Study Source B**

How far does this account support the view that the blockade of the South was effective? Explain your answer using details from the source **and** your knowledge. [7]

**3 Study Source C**

How useful is this drawing in portraying the reality of battles fought during the Civil War? Explain your answer using details from the source **and** your knowledge. [7]

**4 Study Sources D and E**

Is it fair to accuse Sherman of cruelty in his campaign in the South? Explain your answer using details from the sources **and** your knowledge. [10]

**Part B: The Battle of Gettysburg**

You are advised to spend 30 minutes on your answer.

**5** Study Source F

'The Battle of Gettysburg was the most important military event in the Civil War.' How far do you agree with this view? Use the source **and** your knowledge to explain your answer.

**Section B: America in Vietnam**

Study the Background Information below and then answer **all** the questions. Use your knowledge of the topic to help you interpret and evaluate the sources, as appropriate.

**Background Information**

Following the Gulf of Tonkin incident the U.S.A. increased its involvement in Vietnam and by 1968 had committed about 500,000 men to the war. American troops tried to win the support of the South Vietnamese, but they were unable to confront the Vietminh and the Vietcong in open combat. The U.S. bombed North Vietnam heavily. By late 1967 the Americans appeared to have the upper hand, but the Tet Offensive of January 1968 showed that they had made little progress.

You are advised to spend 1 hour in answering Questions 6 to 9.

What does this poster tell you about Vietcong tactics? Explain your answer using details from the source **and** your knowledge. [6]

**7 Study Source B**

How useful is this source as evidence for the effectiveness of American bombing raids? Explain your answer using details from the source **and** your knowledge. [7]

**8 Study Source C**

Why was the President's adviser so pessimistic about the position in Vietnam? Explain your answer using details from the source **and** your knowledge. [7]

**9 Study Sources D and E**

To what extent can the account of the soldier in Source D help you to understand the action of the soldier in Source E? Explain your answer using details from the sources **and** your knowledge. [10]

**Part B: Atrocities in the Vietnam War**

You are advised to spend 30 minutes on your answer.

**10** Study Source F

How convincing is this account of the reasons for atrocities committed by U.S. soldiers in the Vietnam War? Use the source **and** your knowledge to explain your answer.

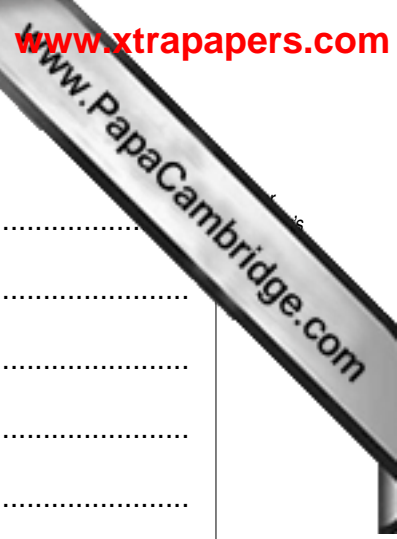

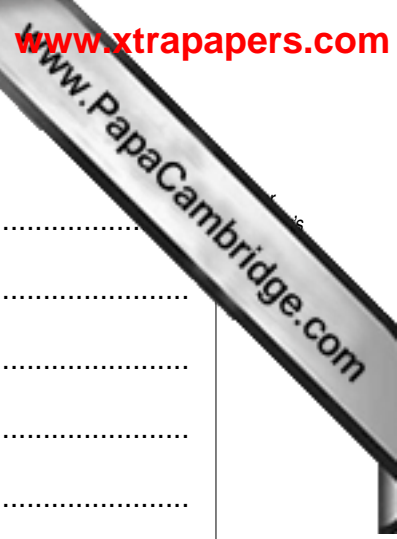

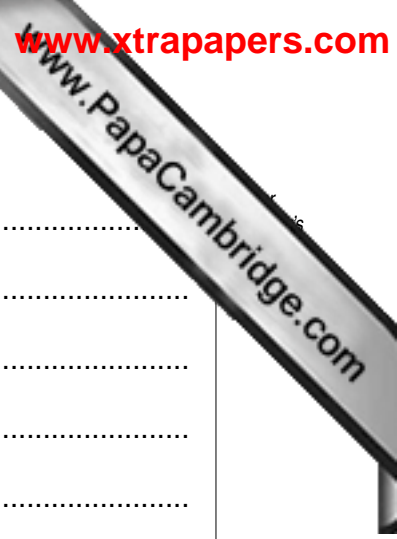
