Why do these sources differ in their views of the California Gold Rush? Explain your answer using details from the sources **and** your knowledge. [10]

## 5 Study **all** the sources (A, B, C, D, E, F, and G).

"The discovery of gold in California was the major cause of people migrating west." To what extent do you agree? Explain your answer using details from **all** the sources **and** your knowledge. [15]

## Depth Study B: The Women's Suffrage Movement 1866-1920

During the period 1866 to 1890, the women's suffrage movement continued to campaign for the right to be granted the vote. It faced many obstacles and met with mixed success.

## 9 Study Sources D and E.

Why do these sources differ in their opinion of the right of women to obtain the vote? Explain your answer using details from the sources **and** your knowledge. [10]

#### **10** Study **all** the sources (A, B, C, D, E, F, and G).

"The movement for women's suffrage faced considerable opposition and made little progress between 1866 and 1890." To what extent do you agree? Explain your answer using details from all the sources and your knowledge.
