General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

- 1 × foamed plastic (expanded polystyrene) cup
- 1 × weighing boat
- 1 × thermometer (−10 °C to +110 °C at 1 °C intervals)
- 4 × test-tubes*
- 2 × boiling tubes*
- 1 × hard-glass test-tube
- 1 × test-tube rack
- 1 × test-tube holder
- 2 × teat/dropping pipette
- 1 × Bunsen burner
- 1 × heat-proof mat
- wash bottle containing distilled water
- pen for labelling glassware
- paper towels
- access to a balance, minimum accuracy 0.1 g
- red and blue litmus papers
- aluminium foil for testing nitrate/nitrite
- wooden splints
- the apparatus normally used in the centre for use with limewater in testing for carbon dioxide

*Candidates are expected to rinse and re-use test-tubes and boiling tubes where possible. Additional tubes should be available.

Where balance provision is limited, some candidates should be instructed to start the exam with different questions. See the current syllabus for balance:candidate ratio.

Materials

The materials listed in the table must be provided to each candidate.

FA 1	150 cm ³	0.00600 mol dm ⁻³ iodine, I ₂	Dilute 60.0 cm ³ of 0.100 mol dm ⁻³ I ₂ to 1 dm ³ . To prepare 0.100 mol dm ⁻³ I ₂ dissolve 80 g of KI [MH] and 25.38 g of I ₂ [MH][N] in each dm ³ of solution. The procedure will take time even with stirring and it may be useful to prepare and leave the solution (covered) overnight before making up to the final volume.
FA 2	180 cm ³	0.0100 mol dm ⁻³ sodium thiosulfate	10-fold dilution of 0.100 mol dm ⁻³ Na ₂ S ₂ O ₃ . For preparation of 0.100 mol dm ⁻³ Na ₂ S ₂ O ₃ see FA 6 .
FA 3 [MH]	10 g	citric acid monohydrate	Provide 10.0±0.2 g of C ₆ H ₈ O ₇ •H ₂ O [MH] in a stoppered bottle.
FA 4 [O][MH]	2 g	sodium nitrate	Provide 2.0±0.2 g of NaNO ₃ [O][MH] in a stoppered bottle.
FA 5 [MH]	10 cm ³	acidified 0.10 mol dm ⁻³ iron(III) chloride	Dissolve 27.03 g of FeCl ₃ •6H ₂ O [C][MH] in each dm ³ solution of 1.00 mol dm ⁻³ hydrochloric acid. To prepare 1.00 mol dm ⁻³ hydrochloric acid, dilute 84 cm ³ of concentrated (35–37%; approximately 11 mol dm ⁻³) hydrochloric acid [C][MH] to 1 dm ³ .
FA 6	200 cm ³	0.100 mol dm ⁻³ sodium thiosulfate	Dissolve 24.82 g of Na ₂ S ₂ O ₃ •5H ₂ O in each dm ³ of solution.
starch indicator	15 cm ³	freshly prepared aqueous starch indicator (approx 2% solution w/v)	See preparation instructions in the current syllabus.
distilled water	50 cm ³	distilled water

dilute hydrochloric acid	10 cm ³	2.0 mol dm ⁻³ HCl	<p>See preparation instructions in the current syllabus.</p> <p>If necessary, each of these reagents can be provided as a communal supply for groups of up to 6 candidates.</p> <p>Invigilators must be alert to the risk of contamination and the opportunity for malpractice when using a communal supply.</p>
dilute nitric acid [C]	10 cm ³	2.0 mol dm ⁻³ HNO ₃	
dilute sulfuric acid [MH]	10 cm ³	1.0 mol dm ⁻³ H ₂ SO ₄	
aqueous ammonia [C] [MH][N]	10 cm ³	2.0 mol dm ⁻³ NH ₃	
aqueous sodium hydroxide [C]	30 cm ³	2.0 mol dm ⁻³ NaOH	
aqueous barium chloride or aqueous barium nitrate	10 cm ³	0.1 mol dm ⁻³ BaCl ₂ or 0.1 mol dm ⁻³ Ba(NO ₃) ₂	
aqueous sodium carbonate [MH]	10 cm ³	1.0 mol dm ⁻³ Na ₂ CO ₃
