SOURCE A

Equality, Diversity and Reducing Conflict

Equality laws in Northern Ireland help to ensure that everyone has equal rights, are treated fairly and have equal opportunities. This helps to make everyone feel included in society and reduces discrimination against minority groups.

Northern Ireland is a culturally diverse society. People from different cultures often share their culture by expressing their cultural identity through celebrations, traditional dance and music. This helps others to learn about their culture and encourages a more inclusive society.

However, in Northern Ireland there is often tension and conflict between people from different groups. This includes conflict between Catholics and Protestants and racist attacks on people from ethnic minority groups.

One of the roles of the Northern Ireland government is to reduce this conflict and build a more peaceful society. It helps achieve this by supporting cross-community projects, raising awareness about racism and using the law to protect people from violence.
