Source for Question 1

The rule of law is considered a basic principle of all constitutional states. Its purpose is to define the relationship between individuals and the state. Any breach of law requires the state to impose sanctions upon the perpetrator, determined through a judicial process. There are, however, theorists who argue that under certain conditions breaching specific laws can be justified. These include Martin Luther King, Gandhi and Henry Thoreau. This principled breach of law is referred to as civil disobedience. Its supporters distinguish this course of action from common criminality.
