2 Study the inscriptions and answer the questions.

To the spirits of the departed. [...]r Celsus, son of Lucius, of the Claudian voting tribe, from ..., 'speculator' of the Second Legion Augusta, An[tonius?] Dardanus Cursor, Valerius Pudens and ...s Probus, 'speculatores' of the legion '(set this up)'.

'London (Londinium). Tombstone, 1st century AD'

Gaius Mannius Secundus, son of Gaius, of the Pollian voting tribe, from Pollentia, a soldier of the Twentieth Legion, aged 52 years, served for 31 years, 'beneficiarius' on the staff of the governor, lies here.

'Wroxeter (Viroconium). Tombstone, ?Before AD 61'

For Nero Claudius Caesar Augustus, son of the deified Claudius, grandson of Germanicus Caesar, great-grandson of Tiberius Caesar Augustus, great-great-grandson of the deified Augustus, in his fourth year of tribunician power, four times acclaimed 'imperator', consul for the fourth time, by decree of the senate the vow was deservedly fulfilled.

'Chichester (Noviomagus). Dedication slab, AD 59'

For the Divine House and the Divine Powers of the Emperors, the ‘vicani’ (people) of Vindolanda ‘(set up this)’ sacred offering to Vulcan, willingly and deservedly fulfilling their vow under the charge of [...].

‘Vindolanda (Chesterholm). Altar, 2nd or 3rd century AD’

To the spirits of the departed, Titinius Felix, ‘beneficiarius’ of the legate of the Twentieth Legion Valeria Victrix, served 22 (?) years, lived 45 years; Iulia Similina his wife and heir [set this up].

‘Chester (Deva). Tombstone, 3rd century AD’

- (a) How useful are these inscriptions in illustrating how the government and administration of Britain change after the Roman invasion? [25]**
- (b) ‘The focus of the Roman occupation was to inspire fear among the natives.’ How far does the available evidence support this view? [25]**
