## **SECTION A**

**Answer AT LEAST two questions from this section.**

- 1 (a) Describe the custodial AND community sentences available to adult offenders convicted in the Crown Court. [18]**  
  
**(b)\*Discuss the extent to which adult sentences achieve the aim of protecting the public. [12]**
  
- 2 (a) Describe the jurisdiction of the three divisions of the High Court AND the routes of appeal from this court. [18]**  
  
**(b)\*Discuss the advantages of using the civil court system to resolve a dispute. [12]**

- 3 (a) Describe AND give examples of the three categories of criminal offence. Detail where each category of offence would be tried. Include pre-trial and trial procedures for deciding on the trial venue. [18]**
- (b)\*Discuss the factors a defendant will need to take into consideration when deciding whether or not to elect to be tried in the Crown Court or the Magistrates' Court. [12]**
- 4 (a) Describe how the courts decide whether or not to grant a suspect bail including any conditions that may be imposed. [18]**
- (b)\*Discuss whether the balance of interests between public safety AND a suspect's right to liberty are adequately protected by the rules on bail. [12]**
- 5 (a) Describe the different ways in which civil legal advice is available to a person who is not eligible for public funding. [18]**
- (b)\*“Government cuts to both civil AND criminal legal aid funding have resulted in many people being denied access to justice.”**

**Discuss the extent to which this statement is true.

## **SECTION B**

**Answer AT LEAST one question from this section.**

- 6 (a) Describe when juries are used and their role in criminal courts and civil courts. [18]**
- (b)\*The following people have received a summons for jury service. Alfie is 18 years old and is related to the defendant. Beatrice has served a 12-year custodial sentence. Charlie served four years for burglary in 1978 and is currently being treated for depression.**

**Explain whether Alfie, Beatrice and Charlie can be jurors. [12]**

- 7 (a) Describe the powers of the police to detain and take samples from a suspect at a police station and any limitations on those powers. Do NOT discuss interviews and searches. [18]**
- (b)\*Michelle is 16 years old. She was arrested on suspicion of arson. She was interviewed on her own for eight hours without a break. Two female officers stripped her completely naked looking for a lighter. Nothing was found so they intimately searched her.**

**Explain to Michelle whether or not her treatment was lawful. [12]**
