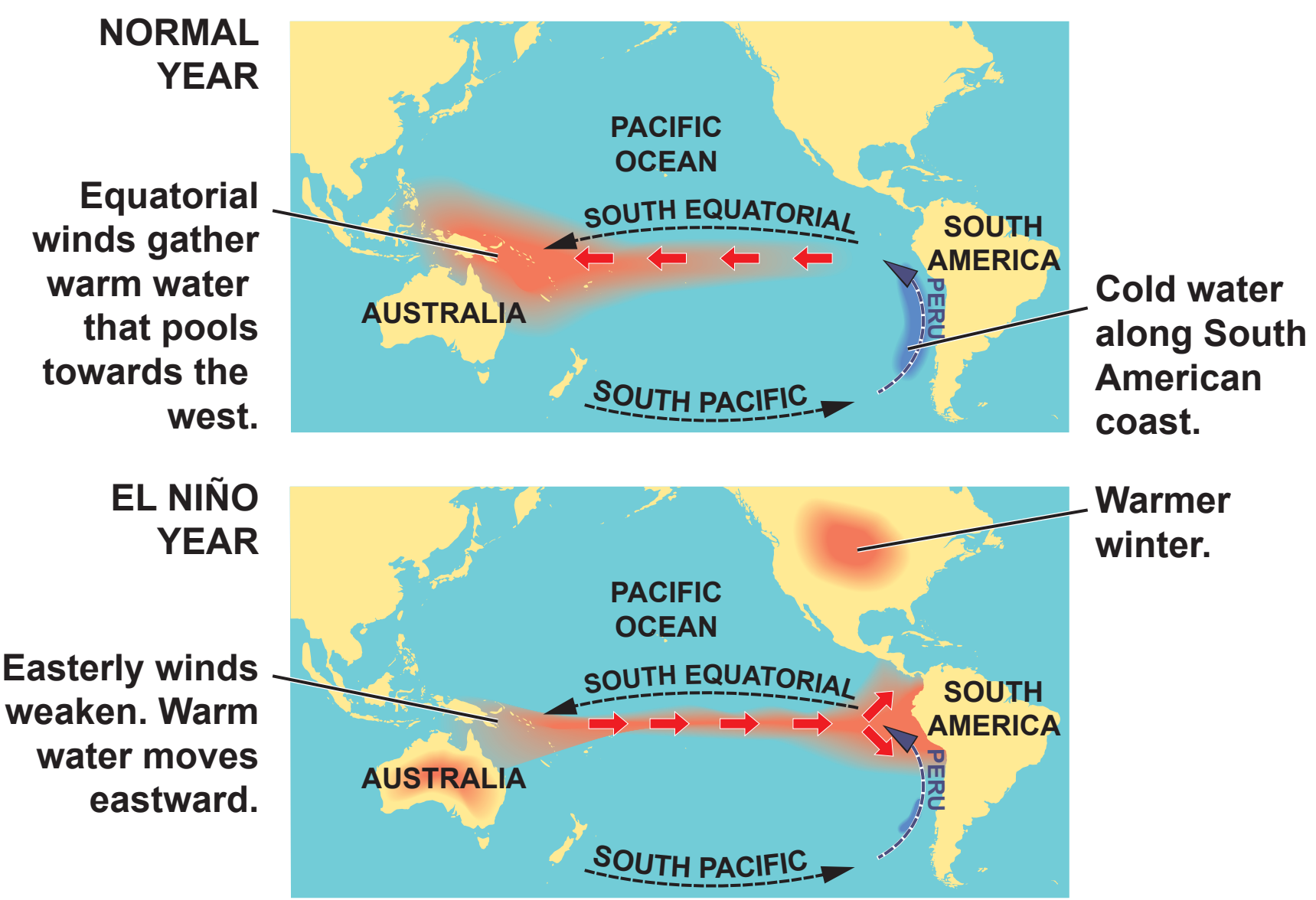


Fig. 2 A painting from 1677 of the frozen River Thames. People are walking on the ice.

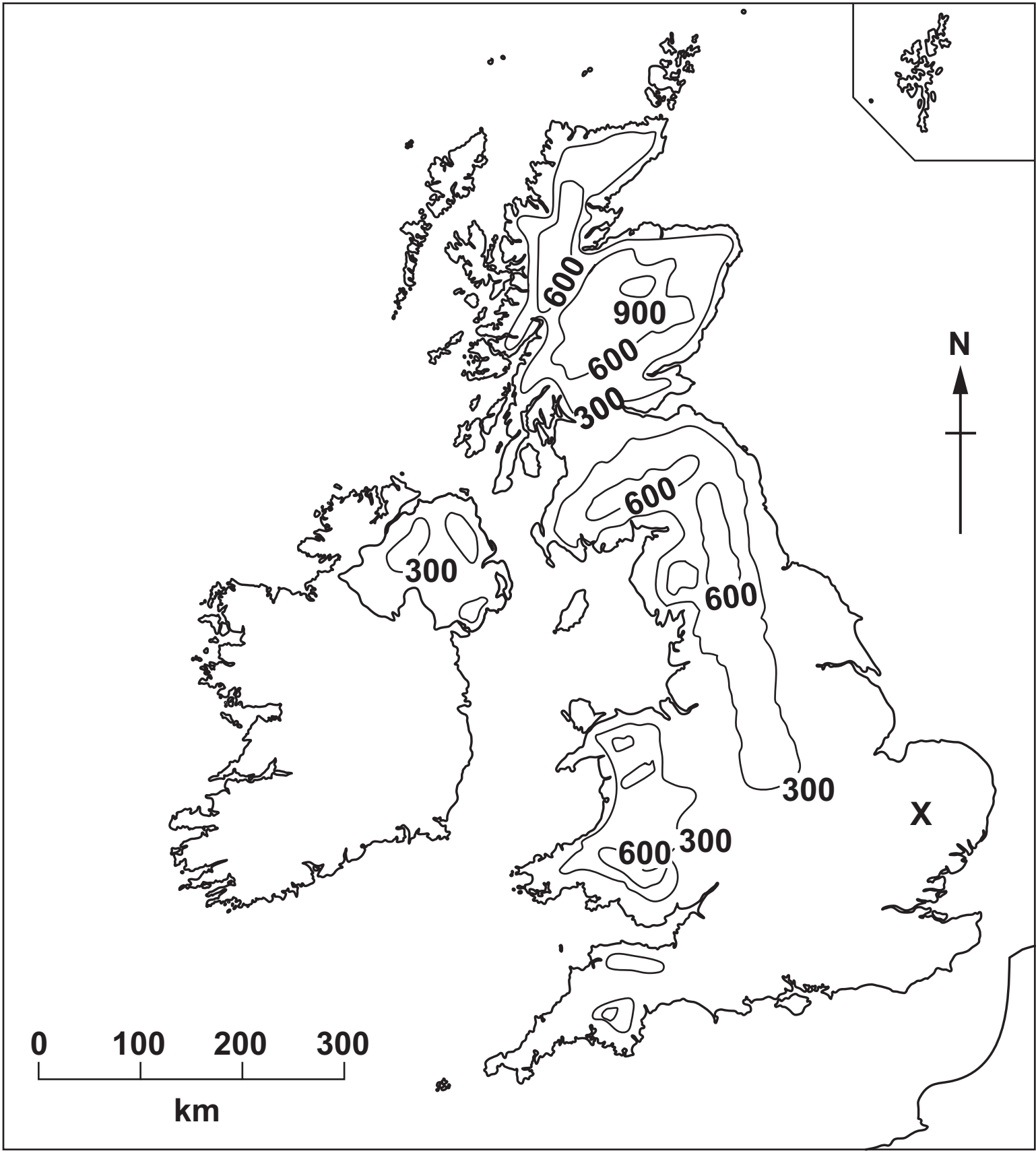
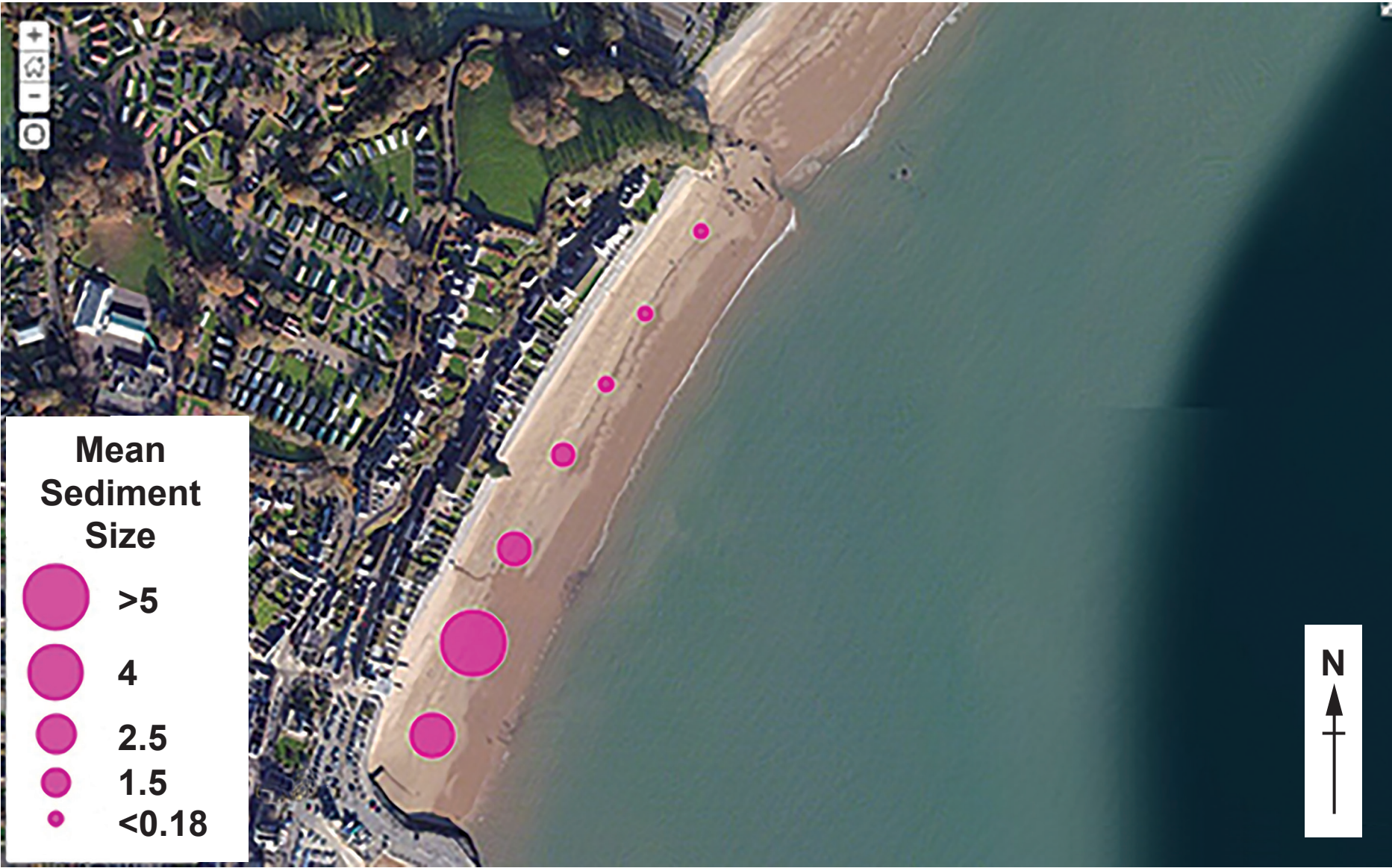




Fig. 4 Students' data presentation from physical geography fieldwork data
