THE EXEMPLIFICATION OF KEY SKILLS

The following tables give some examples of Child Development contexts in which naturally occurring key skills evidence could be accumulated.

Note: If producing certain types of evidence creates difficulties due to disability or other factors, the candidate may be able to use other ways to show achievement. The candidate should ask the tutor or supervisor for further information.

The first table focuses on Communication (Level 2). Candidates must provide evidence to meet the standards for C2.1a, C2.1b, C2.2 and C2.3:

- Take part in a group discussion
- Give a talk of at least 4 minutes
- Read and summarise information from at least two documents (minimum 500 words) about the same subject
- Write two different types of documents (one of which must be at least 500 words), each one giving different information

C2.1a TAKE PART IN A GROUP DISCUSSION

C2.1b GIVE A TALK OF AT LEAST FOUR MINUTES

Give a talk of at least four minutes.	Speak clearly in a way that suits their subject, purpose and situation. A record from someone who has observed the talk including a description of any image/support material used or a video/ audiotape or preparatory notes with images/ support material.	Produce a talk on a issue linked to the syllabus content such as Information on current eating guidelines for pregnant woman as set by government targets. Arrangements for the birth home versus hospital ,positions for giving birth ,role of the partner , pain relief . Value of learning aids to promote development Disabilities and support for families .

C2.2 READ AND SUMMARISE INFORMATION

APPLICATION OF NUMBER: LEVEL 2

Candidates must:

Undertake at least **ONE** activity that includes tasks for all three of N2.1, N2.2 (a or b or c or d) and N2.3 should be carried out*. Overall, through one or more activities the candidate must:

- use **TWO DIFFERENT** sources which include material containing a chart or graph (N2.1)
- do calculations for a, b, c and d (N2.2)
- present findings in **TWO DIFFERENT** ways using charts, graphs or diagrams (N2.3).

* Where it is necessary to carry out additional activities to meet all the requirements of N2.2 (a, b, c, d) each activity must include tasks for N2.2 and N2.3 or N2.1 and N2.2.

N2.2 USE THIS INFORMATION TO CARRY OUT MULTI- STEP CALCULATIONS

Perform a number of different types of multi-step calculations, with and without a calculator for each of a, b, c and d showing methods, appropriate rounding and levels of accuracy; how the candidate checked that the methods and results made sense.	Candidates can work out room dimensions and furniture sizes when planning a nursery. Explore maternity benefits, variations in maternity pay and the necessary expenditure of having a baby. Could cost new products versus second hand. Nutritive value of meals for toddlers In all cases methods should be checked.

N2.3 INTERPRET THE RESULTS OF YOUR CALCULATIONS AND PRESENT YOUR FINDINGS			
Candidates must:	Evidence must show candidates can:	Examples of evidence:	Suggested context:
Interpret the results of your calculations and present your findings.	Select effective ways to present their findings. Present their findings clearly using a chart, graph or diagram and describe their methods. Use more than one way of presenting their findings. Describe what their results tell them and how these meet their purpose.	Candidates must draw conclusions from their results, graphs, diagrams, etc. These should be related to the original purpose of the task and main findings highlighted. This should either prove or disprove their original hypothesis. Select the most appropriate method to display findings. Explain their choice of methods.	Present findings using suitable method, pie chart, table describing what calculations have shown, E.g. Pie chart on Nutritive value. Chart to show average costs over a set period of time . Table to compare cost of second hand furniture with new, or a number of shops / brands.

INFORMATION and COMMUNICATION TECHNOLOGY: LEVEL 2

Candidates must overall, through two or more activities:

- include at least one ICT based information source
- include at least one non ICT based information source
- use at least one example of text, one example of image and one example of number
- present combined information such as text with image, text with number, image with number
- present evidence of purposeful use of email

WORKING WITH OTHERS: LEVEL 2

Candidates must provide at least one example of meeting the standards for WO2.1, WO2.2 and WO2.3, to include work in a group or team situation. They must check progress on two occasions (for WO2.2).

WO2.3 REVIEW WORK WITH OTHERS AND AGREE WAYS OF IMPROVING

IMPROVING OWN LEARNING AND PERFORMANCE: LEVEL 2

Candidates must provide at least one example of meeting the standard for LP2.1, LP2.2 and LP2.3 (the example should cover at least three targets). Overall, candidates must show they can use at least two different ways of learning to improve their performance.

LP2.1 SET TARGETS USING INFORMATION FROM APPROPRIATE PEOPLE

Help set targets with an appropriate person and plan how these will be met.	Provide information to help set realistic targets for what they want to achieve. A detailed action plan for each target, clearly showing actions, deadlines and how the candidate will manage their time. A candidate statement showing that they know where and when support and resources can be had and from whom. A candidate statement showing they fully understand the arrangements for progress reviews. The candidate must know who will conduct the review, what form it will take, where and when it will happen.	Planning work in such a way that will allow opportunities for students to identify at least one target. Planning a presentation or group practical / experimental session will involve both short and longer-term targets and should allow students to identify at least two targets. Use their action points to help manage their time well, revising their plan when needed. Choose ways of learning to improve their performance working for short periods without close supervision. Identify when they need support and use this effectively to help meet targets.	A candidate log or workbook, showing how and when each point in the action plan was addressed. A record on the action plan of how closely the candidate kept to their planned timings. A record on the action plan showing what revisions the candidate considered as necessary, why they were made and how effective these were. A learning log or workbook, clearly showing how the learning was carried out and why different ways of learning were adopted at different times. Reference in the learning log or workbook to the candidate's identification of when and why support is needed. A candidate statement on the effective use of the support.	If student takes responsibility for successfully executing plan in LP2.1, and chooses to follow plan to achieve target by individual research, e.g. planning practical work, investigating special diets. Any presentation or group activity will involve students following a plan which may be designed in LP2.1 and making decisions about best way of achieving task, may identify ways of learning. This may be written by the candidate, recorded by the assessor or it could be taped. It could take the form of a tick box with brief comments. A candidate statement identifying how they learn best e.g. by doing, by studying, working alone etc. Suggestions from the candidate how they might improve their performance. PROBLEM SOLVING: LEVEL 2

Candidates must provide at least one example of meeting the standard for P23.1, PS2.2 and PS2.3. The example should include exploring at least three different ways of tackling a problem (for PS2.1).

PS2.1 IDENTIFY A PROBLEM AND IDENTIFY WAYS OF TACKLING IT

Identify a problem, with help from an appropriate person and identify different ways of tackling it.	Provide information to help identify a problem accurately describing its main features. Identify how they will know the problem has been solved. Come up with different ways of tackling the problem.	An account of a discussion between the candidate and another appropriate person. A detailed description of the problem's main features. A candidate statement describing, in detail, the desired outcome(s). A candidate statement clearly showing they have considered at least two different approaches to tackling the problem e.g. a variety of visual, numerical, physical methods and mind-mapping, asking others about similar problems, by experimenting, by studying, by imitation.	Planning their work especially for the controlled tasks. Analysis of a persons lifestyle and any modifications needed during pregnancy. Ethical dilemmas , teenage pregnancies. Analysis of sample diets during pregnancy or childhood. Dealing with challenging behaviour .in childhood.
PS2.2 PLAN AND TRY OUT AT LEAST ONE WAY OF SOLVING THE PROBLEM

Plan and try out at least one way of solving the problem.	Confirm with an appropriate person how they will try to solve the problem. Plan what they need to do, identifying the methods and resources they will use. Use their plan effectively, getting support and revising their plan when needed to help tackle the problem.	A signed record of a discussion with an appropriate person. A detailed candidate action plan. An authenticated log or workbook. It may be confirmed by anyone in authority who has observed the candidate at work. A statement by a third party referring to any support offered and taken. Annotations on the plan showing when and why revisions were needed and what revisions were made.	Selecting appropriate labour saving equipment for specific tasks e.g. Producing foods for weaning. Producing a range of dishes for specific dietary needs e.g. Lacto vegetarian. Overcome problems they may experience planning and executing a presentation to their peers or a younger audience.

PS2.3 CHECK IF THE PROBLEM HAS BEEN SOLVED AND IDENTIFY WAYS TO IMPROVE YOUR PROBLEM SOLVING SKILLS

Check if the problem has been solved and identify ways to improve problem solving skills.	Check if the problem has been solved by accurately using the methods they have been given. Describe clearly the results, including the strengths and weaknesses of how they tackled the problem. Identify ways of improving their problem solving skills.	A candidate record showing in detail what was checked and which method was used. A detailed account of the results by the candidate. A brief analysis by the candidate of both the strengths and weaknesses of how the problem was tackled. A record of assessor feedback questioning. A candidate account of the checking process and assessor feedback.	Assessing the usefulness of tackling problem. May involve discussion with tutor. Checking the ways of solving problem are appropriate.
